145. Crash Description/Narrative

Vehicle 1 was traveling westbound on Rt 88. Vehicle 2 was in the parking lot of Tony's Pizza, 2115 Rt 88 waiting to cross the roadway to utilize Harding Dr. An unknown vehicle traveling westbound in front of Vehicle 1 stopped to allow Vehicle 2 to cross the roadway. Vehicle 1 proceeded to improperly pass the unknown vehicle as vehicle 2 entered the roadway. As a result a right angle collision occurred between vehicle 1 and 2.

Driver 1 advised me of the following:
He was traveling westbound on Rt 88 approaching the intersection with Harding Dr. An unknown vehicle stopped in front of him to turn into Tony's Pizza. He proceeded to pass the unknown vehicle on the shoulder of the road. Vehicle 2 then entered the roadway and collided with his vehicle.

Driver 2 advised me of the following:
He was in the parking lot of Tony's Pizza, 2115 Rt 88 waiting to cross the roadway to Harding Dr. An unknown vehicle stopped to allow him cross Rt 88. As he proceeded across the roadway vehicle 1 appeared in front of his vehicle and a collision occurred.

Vehicle 1 is found to be at fault for the collision and has been issued a summons for Careless Driving

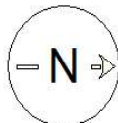

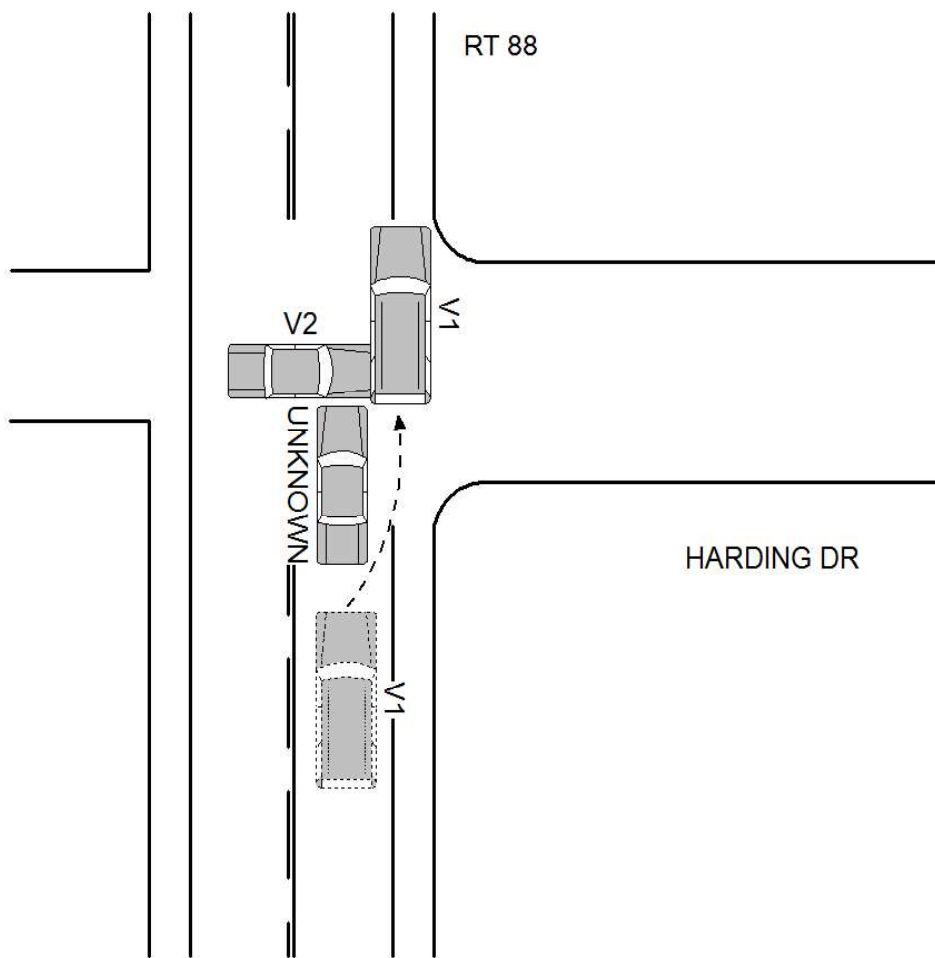
