145. Crash Description/Narrative

Vehicle#1 was traveling South on Burrsville Rd. in the area of Route 88. Vehicle#2 was traveling directly in front of Vehicle#1. As Vehicle#2 came to a complete stop, at the stop sign located at Burrsville Rd. and Rt. 88, Vehicle#1 stopped behind Vehicle#2. Driver#1 stated that she was watching oncoming traffic on Route 88 and not Vehicle#2. Driver#1 advised that she thought Vehicle#2 merged into traffic at which time she pulled forward causing Vehicle#1 to strike Vehicle#2. Driver#2 stated that he was stopped when Vehicle#1 struck him. Driver#1 was found to be at fault for the crash. Both drivers refused first aid, vehicles were moved prior to arrival.

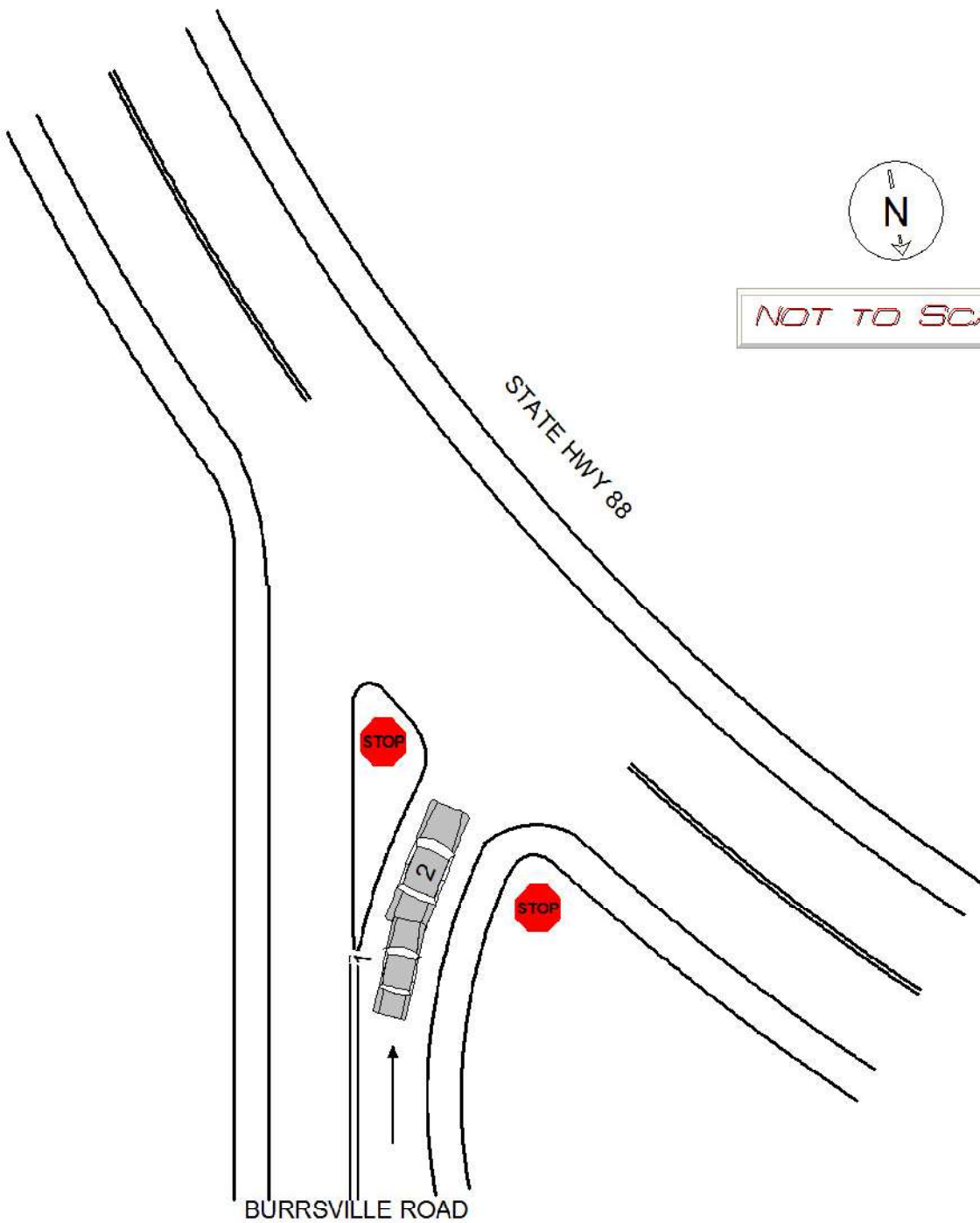
