145. Crash Description/Narrative

Vehicle #1 was stopped at a stop sign on Burrsville Road, near the intersection of Rt. 88. Vehicle #2 was stopped at the same stop sign on Burrsville Rd., directly in front of Vehicle #1.

The driver of Vehicle #1, proceeded forward and struck the rear-end of Vehicle #2, at a slow speed. There were no injuries reported and both vehicles were later driven from the scene. Vehicle #1 had a small scuff on its front bumper. I could not observe any damage on Vehicle #2 as it had several large dents that were from a previous accident as they were covered in rust.

The driver of Vehicle #1 stated that she initially stopped at the stop sign and observed Vehicle #2 stopped in front of her vehicle. She stated that she observed Vehicle #2 pull forward to enter Rt. 88 and that she took her foot off the brake and coasted forward. She stated that she did not see that the driver of Vehicle #2 had stopped after he had edged out forward to check the traffic. She stated that she rolled into the rear-end of Vehicle #2, without putting her foot on the gas pedal.

The driver of Vehicle #2 stated that he was completely stopped at the stop sign when he was struck in the rear by Vehicle #1. He pointed at a large, rusty dent that was on his vehicles steel bumper and stated that the damage was done by Vehicle #1. I advised him that I believed that the plastic fender on Vehicle #1 would have

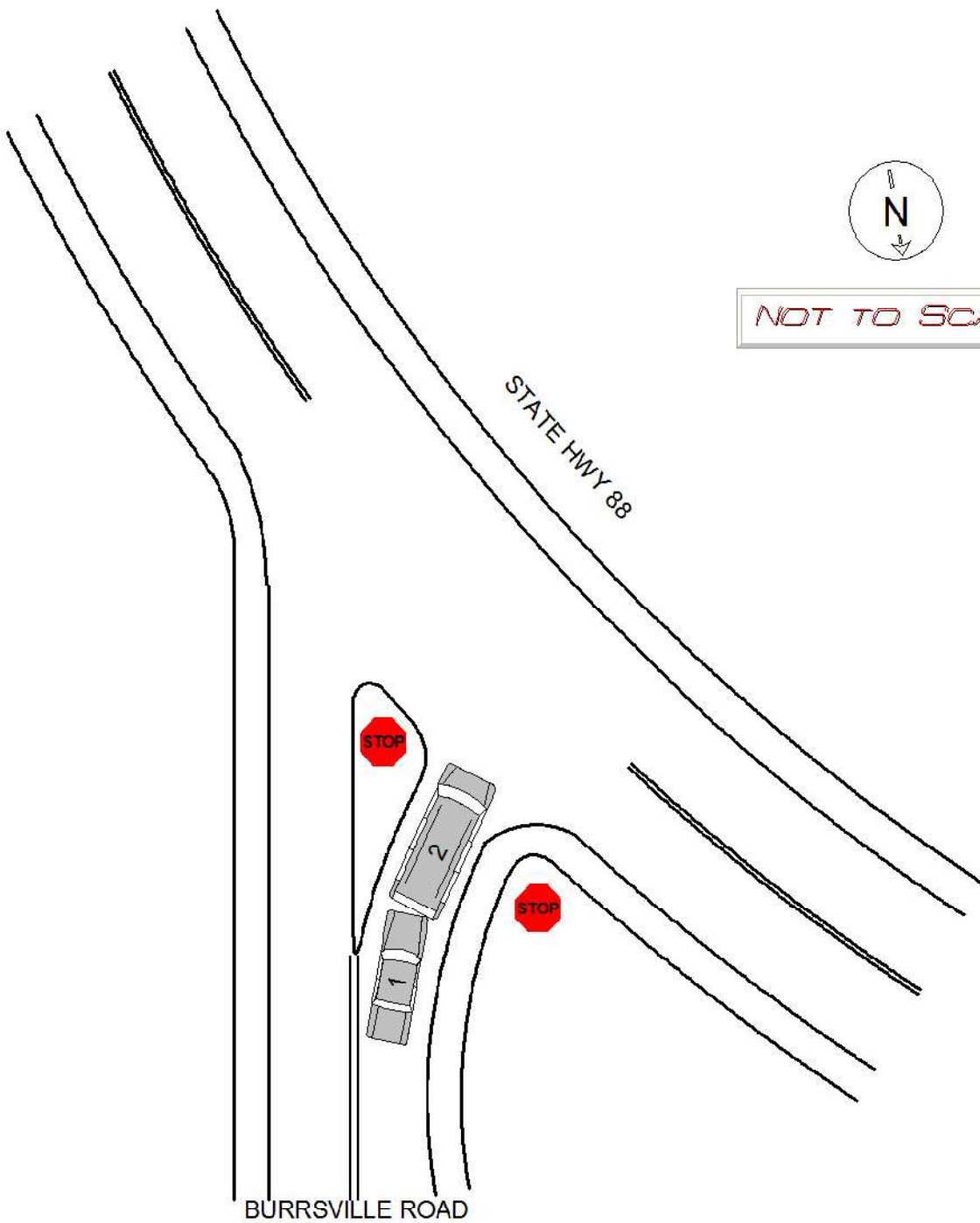
