145. Crash Description/Narrative

Driver of V1 stated that she was traveling westbound on Route 88 and was attempting to make a left turn onto Jordan Road but due to the weather conditions and speed she was traveling made the left turn too short and crashed into V2.

Driver of V2 stated he was stopped at the red light on Jordan Road at the intersection with Route 88 when V1 attempted to make a left turn from Route 88 and crashed into his vehicle which was still stopped.

Based on my investigation and observations on scene I determined V1 to be at fault for the motor vehicle crash.

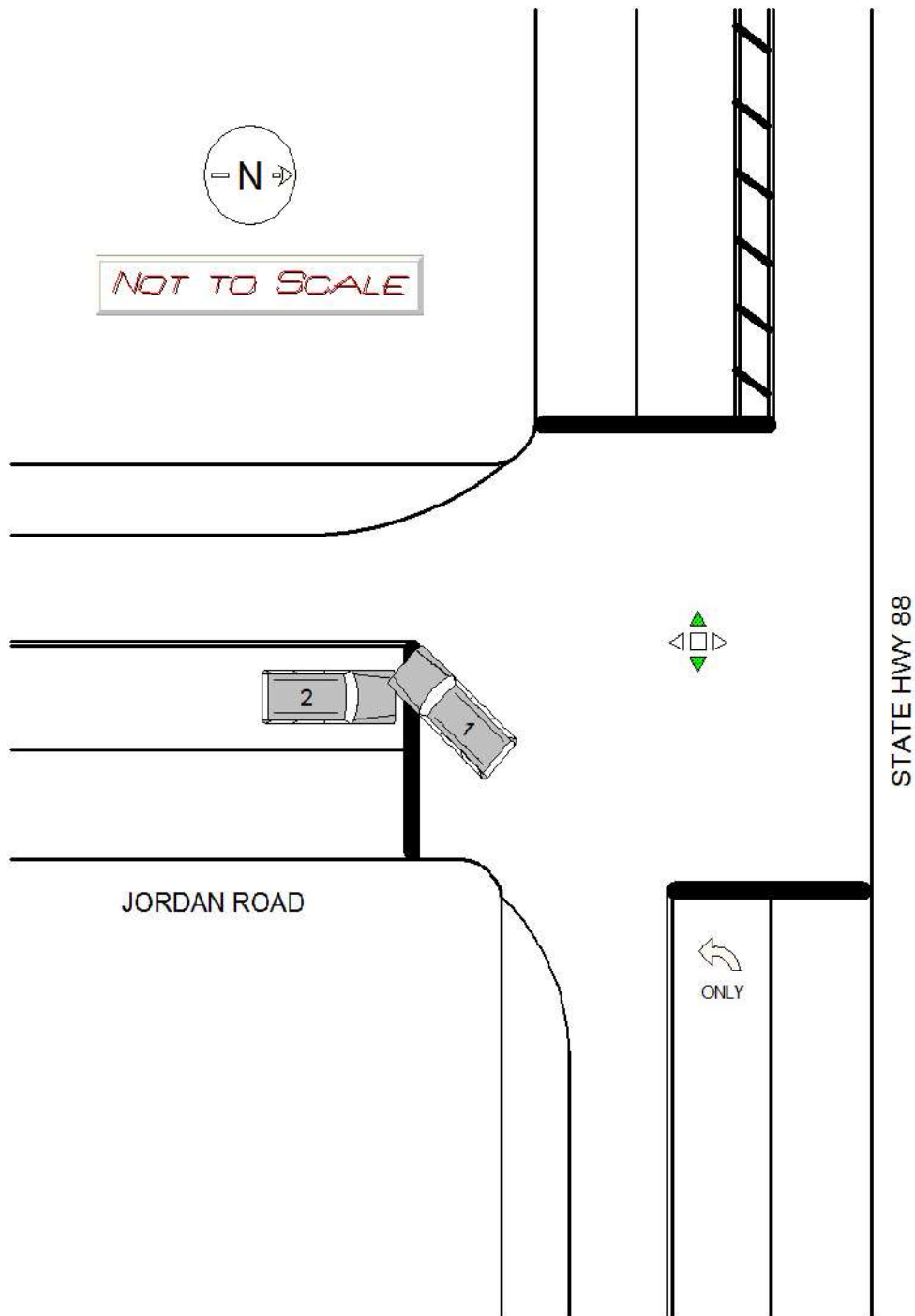
