145. Crash Description/Narrative

A motor vehicle crash occurred on Jack Martin Blvd approximately 25 feet north of Frank Neri Drive.

Driver of Vehicle #1 advised he was traveling south on Jack Martin Blvd towards Route 70. Driver #1 advised there was debris in the middle of the roadway and he attempted to move around it. Driver #1 advised he observed Vehicle #2 stopped and he attempted to brake where he skid and struck the rear of Vehicle #2.

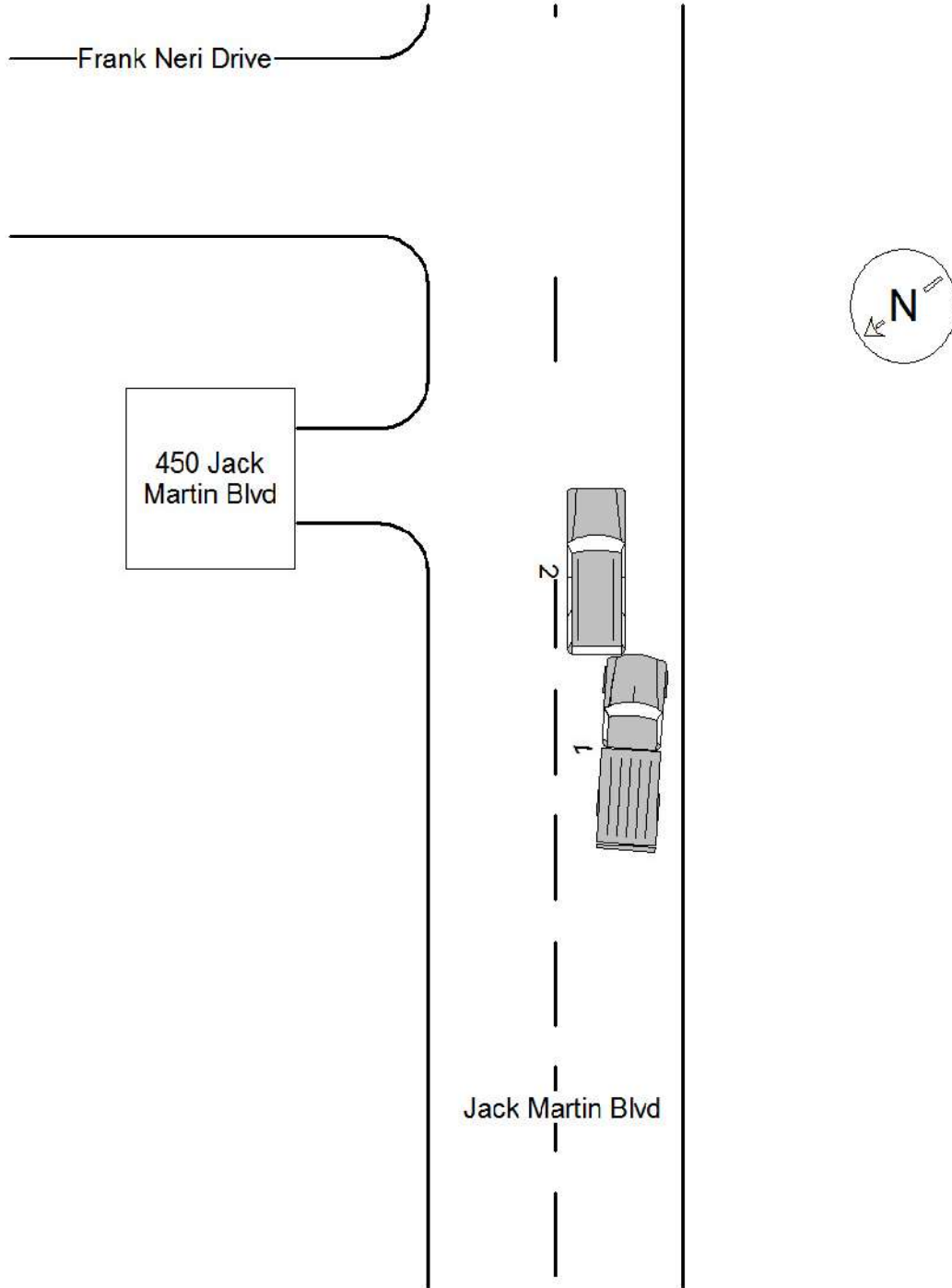
