145. Crash Description/Narrative

Vehicle two was traveling east on Rt 88, at the intersection of Laurel Brook Dr. Vehicle one was making a left turn onto Rt 88 west, from Laurel Brook Dr. Vehicle two struck vehicle one.

The operator of vehicle two stated she was traveling east on Rt 88 when vehicle one entered her lane of travel from Laurel Brook Dr. The operator of vehicle two stated she could not stop her vehicle before striking vehicle one.

The operator of vehicle one stated she was stopped on Laurel Brook Dr. waiting to make a left turn onto Rt 88 west. The operator of vehicle one stated the operator of vehicle two, who was stopped in traffic, waved her out to make the left turn. The operator of vehicle one stated as she began to make a left turn, vehicle two proceeded and struck her vehicle.

There were no reported injuries.

I observed damage to the middle, left side of vehicle one. I also observed damage to the front of vehicle

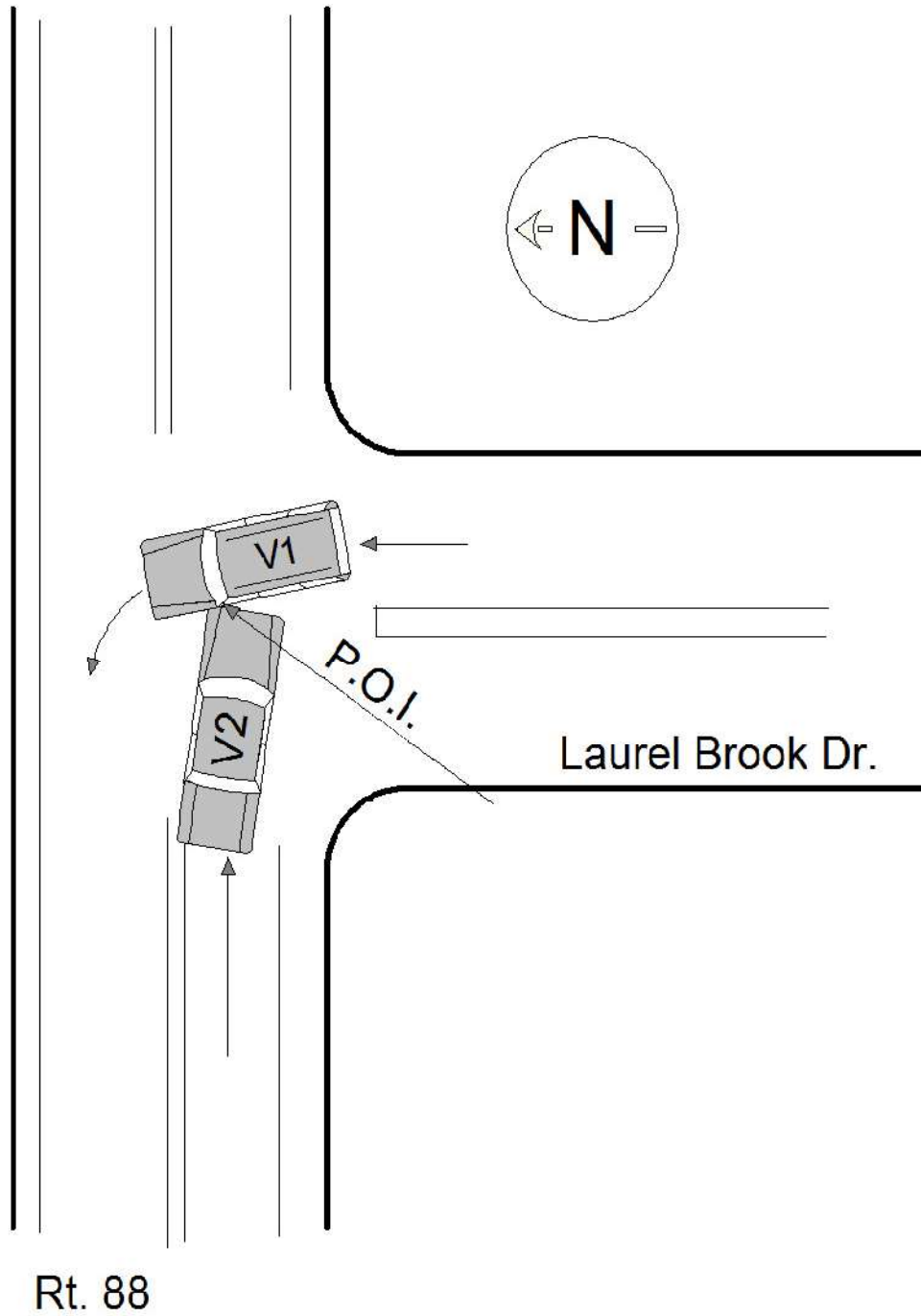
