145. Crash Description/Narrative

Vehicle 1 was traveling on Rt 88 East bound, and had just passed Frank Neri Dr and pulled off to the shoulder safely. Vehicle 2 was also traveling on Rt 88 East and was approaching the area where vehicle 1 was at pulled over. Vehicle 1 then attempted to merge back onto Rt 88, and in doing so collided with vehicle 2.

There were no reported injuries at the scene, and minor damage was observed to both vehicles.

The driver of vehicle 1 stated he was traveling on Rt 88 East and pulled over to the shoulder lane to review his GPS. After a few moments he attempted to merge back onto Rt 88 and stated he did not see vehicle 2 approaching and caused the collision. The driver of vehicle 1 was issued a summons for Careless Driving 39:4-97 T-152751.

The driver of vehicle 2 stated he was traveling on Rt 88 and was approaching the area where vehicle 1 was off to the shoulder. As he got closer, vehicle 1 merged into the travel lane on Rt 88 and collided with his vehicle.

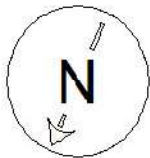

Motor Vehicle Crash Diagram

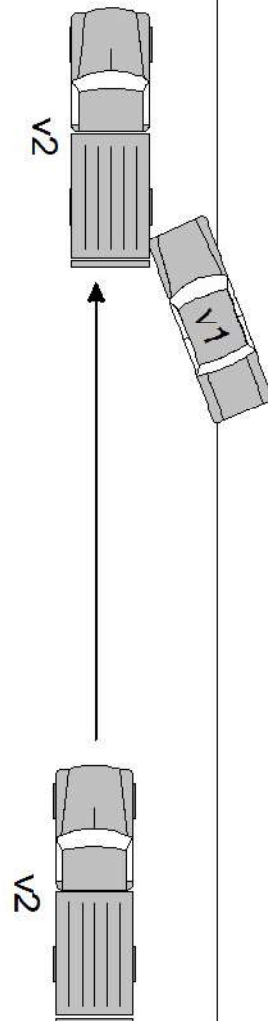
