145. Crash Description/Narrative

The crash occurred in the left lane of travel at the intersection of Rt. 88 and Rt. 70. Vehicle two was stopped at the traffic light on Rt. 88 west bound waiting to turn on to Rt. 70 west bound. Vehicle one, while attempting to turn right off of Rt. 70 east bound, on to Rt. 88 east bound, crossed over the center line and struck Vehicle two. Vehicle one then crossed over the curbed median onto Rt. 88 east bound and struck the curb on the opposite side of the road.

The Driver of Vehicle one stated the following: While attempting to turn right off Rt. 70 on to Rt. 88, her car began to slide due to the rain and the fact that her tires were "bald". Her car continued into the other lane of travel and struck Vehicle two. The Driver of Vehicle one stated she was not injured.

The Driver of Vehicle two stated the following: He was sitting at the light on Rt. 88 waiting to turn right on to Rt. 70, when Vehicle one stuck his vehicle. Vehicle one then drove over the median in an attempt to leave the scene. Vehicle one then struck the curb on the opposite side of the road and came to a stop. The Driver of Vehicle two had a complaint of pain in the left side of his face and left leg, he was transported to Ocean Medical Center by Brick EMS 533.

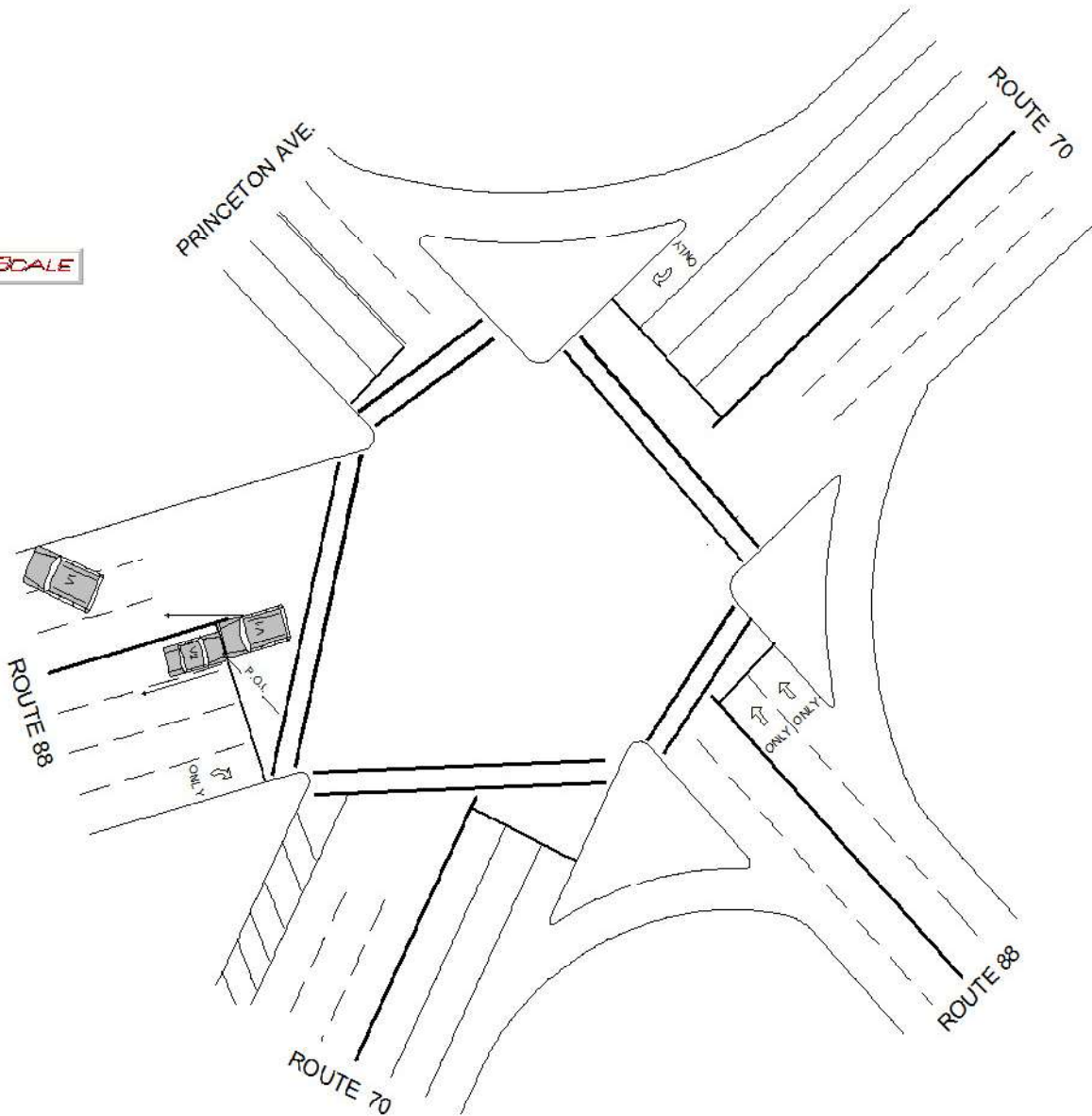
