145. Crash Description/Narrative

Driver vehicle 2 responded to headquarters in reference to a hit and run crash that just occurred.

Investigation revealed vehicle 1 rear ended vehicle 2 on Rt 88 approximately 40 feet east of Jack Martin Boulevard.

Driver vehicle 2 stated he was stopped in traffic at a red signal on Rt 88 when his vehicle was rear ended.

Driver vehicle 1 observed a silver Subaru directly behind his vehicle. When the signal turned green driver vehicle 2 pulled over. At this time the silver Subaru (vehicle 1) drove past him and continued to travel north on Jack Martin Boulevard towards Lakewood. Driver vehicle 2 got behind vehicle 1 and took a photograph of the vehicle and license plate. Driver vehicle 2 called the Brick Township Police Department in reference to the crash. He was advised to respond to headquarters to report the crash. Driver vehicle 2 stated the operator of vehicle 1 was an elderly female with reddish hair.

Follow up investigation revealed the operator of vehicle 1 to be the registered owner. I left a message for the registered owner on her cell phone. Later in the evening I received a call from the registered owners grandson, James Rosa. I explained the incident to James Rosa, who advised his grandmother was operating the vehicle today. He observed minor damage to the front bumper of the vehicle, which he indicated was from today's crash.

145 Crash Description

James Rosa advised his grandmother was found sitting in her vehicle at the Ocean County Courthouse parking lot. He received a call from the Toms River Police who advised she was alone in the car and appeared confused. James Rosa stated his grandmother is suffering from early stages of dementia. I informed James Rosa I would be sending motor vehicle summonses in the mail in reference to the crash. I also advised Rosa I would have driver 1's license retested by the Motor Vehicle Commission.

Through my investigation, I determined driver vehicle 1 to be at fault for the crash. In addition to the careless driving summons, driver 1 was also issued a summons for leaving the scene of a crash.

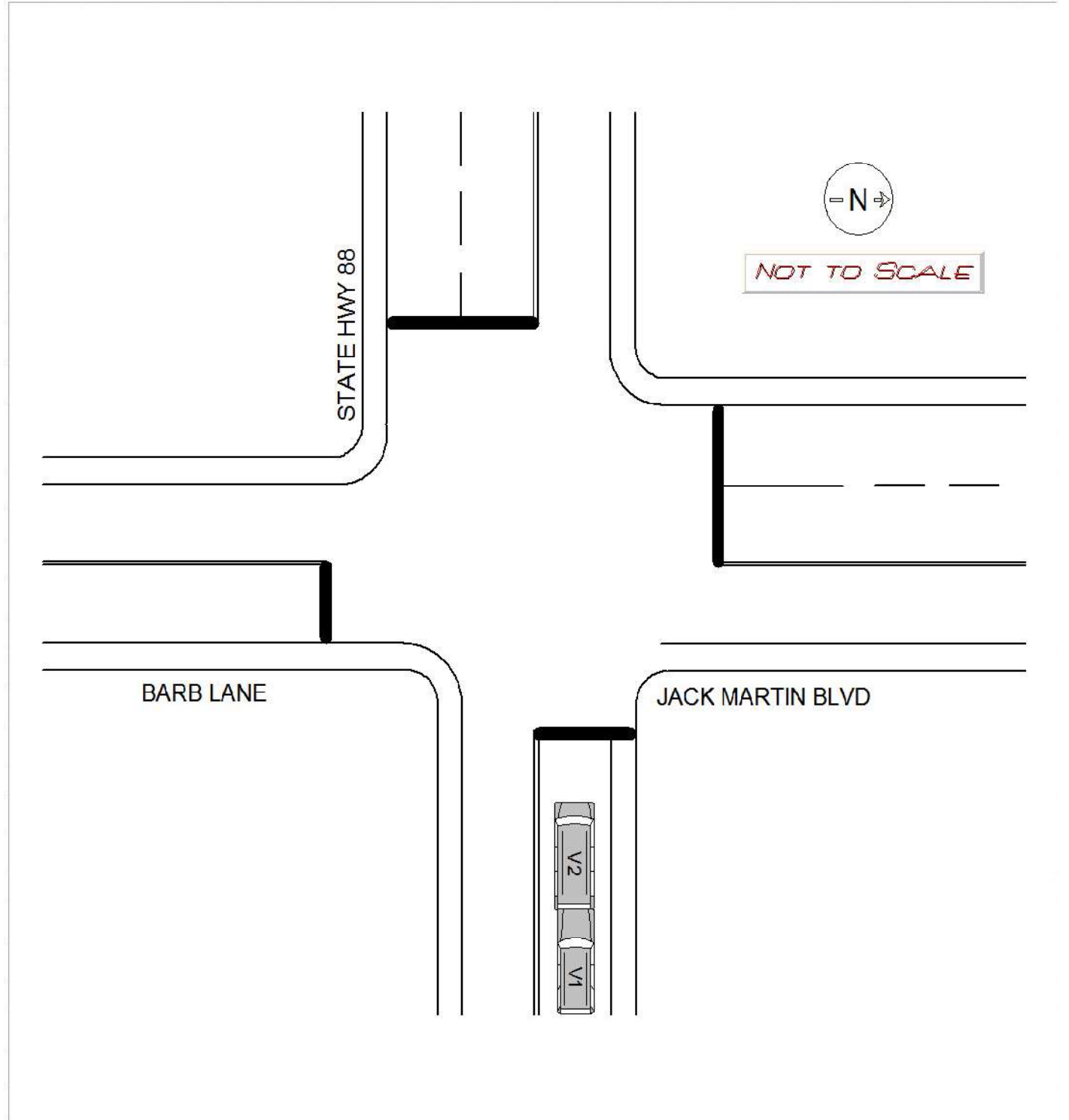
