145. Crash Description/Narrative

Vehicle 1 was traveling on John St approaching the intersection for Rt 88. Vehicle 2 was traveling on Rt 88 West and was approaching John St. Vehicle 1 stopped at the stop sign on John St. and was waiting to turn left onto Rt 88 East. As vehicle 1 then began to inch closer to Rt 88 and was waiting to turn left vehicle 2 approached and the front of vehicle 1 was in the intersection, making no room for vehicle 2 to pass which caused the collision.

There was minor damage to vehicle 1, and moderate damage to vehicle 2. Vehicle 2 was towed by PPTD, the driver of vehicle 2 complained of head pain but refused first aid attention at the scene.

The driver of vehicle 1 stated she stopped at the stop sign on John St and as she moved forward to make a left turn onto Rt 88 she did not see vehicle 2 approaching.

The driver of vehicle 2 he was traveling on Rt 88 West and was approaching the area of John St when vehicle 1 struck his vehicle.

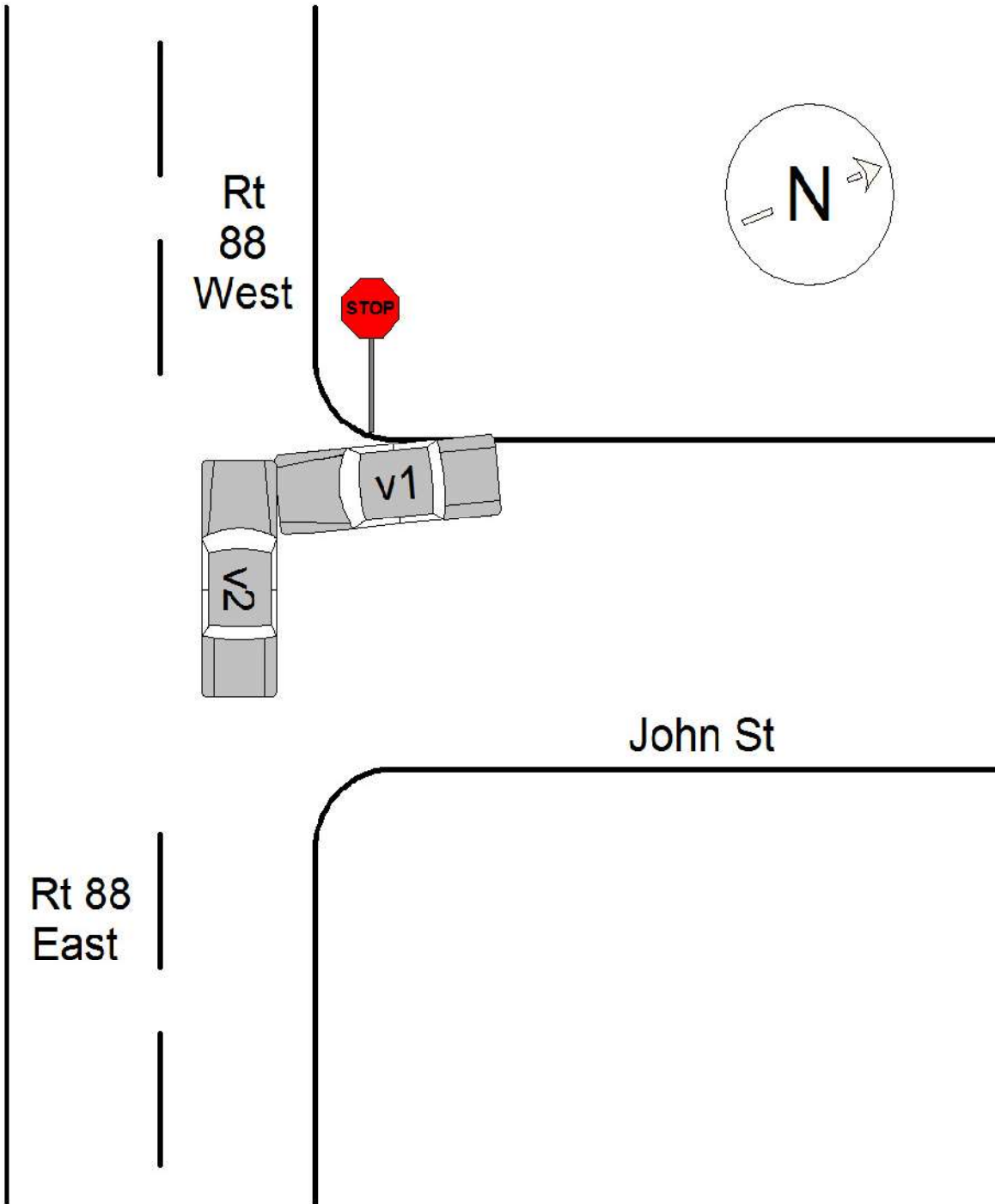
