Crash occurred on Van Zile Rd. northbound, approximately 200 feet south of RT 70.

Driver #2 stated she was traveling north on Van Zile Rd. approaching RT 70 when vehicle #1 came out of the jug handle and entered into her travel lane. She advised she swerved to avoid a collision; but she couldn't and was subsequently struck by vehicle #1.

Driver #1 advised she came around the jug handle and stopped at the stop sign waiting to make a right onto Van Zile Rd. She stated it appeared clear, so she started to pull out and enter into the left turn only lane for RT 70 westbound. While doing so, she advised vehicle #2 came from somewhere and she subsequently struck the side of vehicle #2.

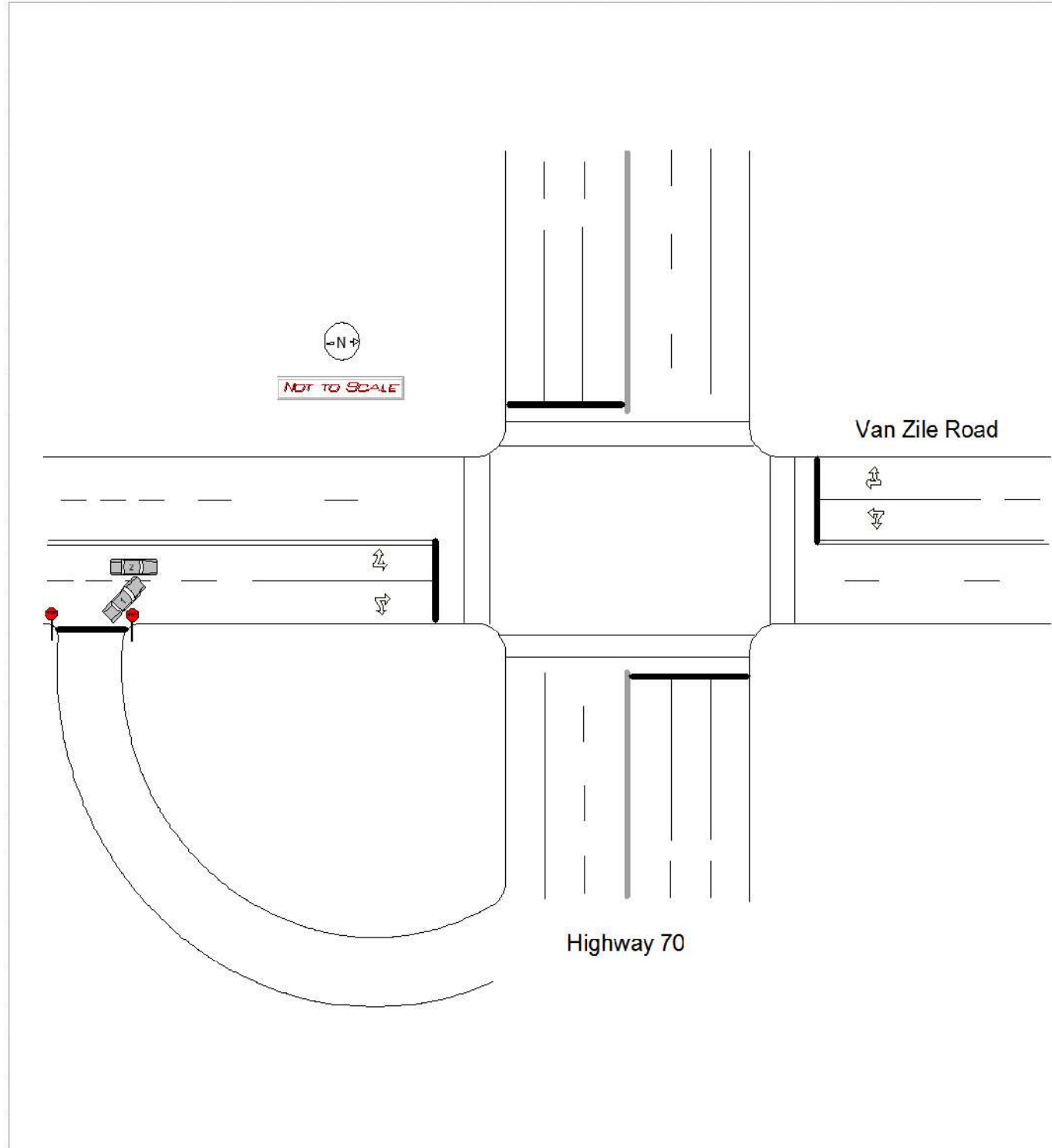
