145. Crash Description/Narrative

A motor vehicle crash occurred on Van Zile Road approximately 10 feet south of Route 70.

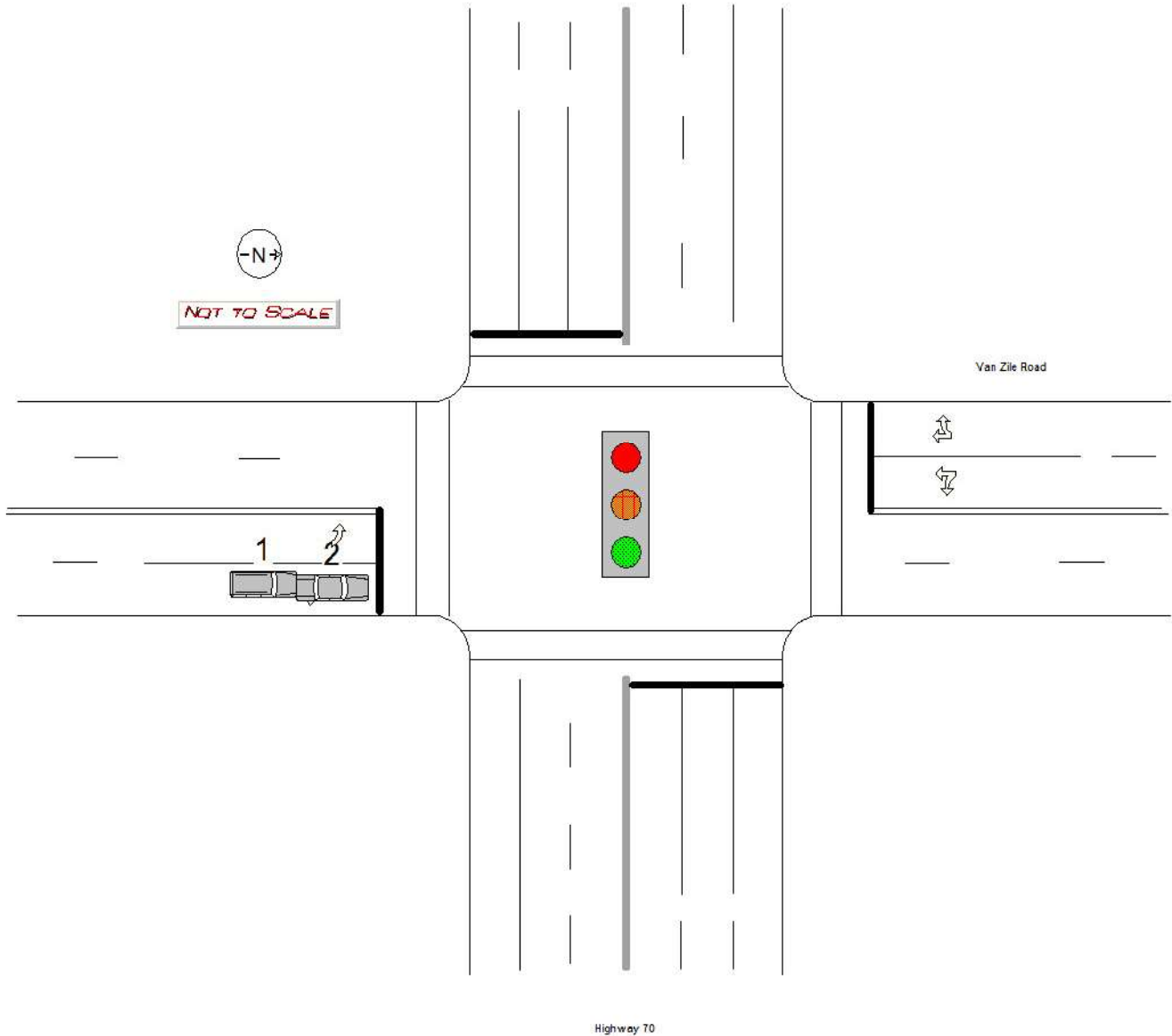
