145. Crash Description/Narrative

Vehicle 1 was traveling east on Route 88, approximately 250 feet east of Post Road. Vehicle 2 was traveling directly behind Vehicle 1.

The driver of Vehicle 2 stated Vehicle 1 "stopped short" in front of Vehicle 2, and he could not stop Vehicle 2. Vehicle 2 crashed into the rear of Vehicle 1, causing damage to both vehicles. The driver of Vehicle 2 stated Vehicle 1 did not stop or pull over following the crash, and continued east on Route 88.

The driver of Vehicle 2 described Vehicle 1 as a newer model silver Jeep Wrangler.

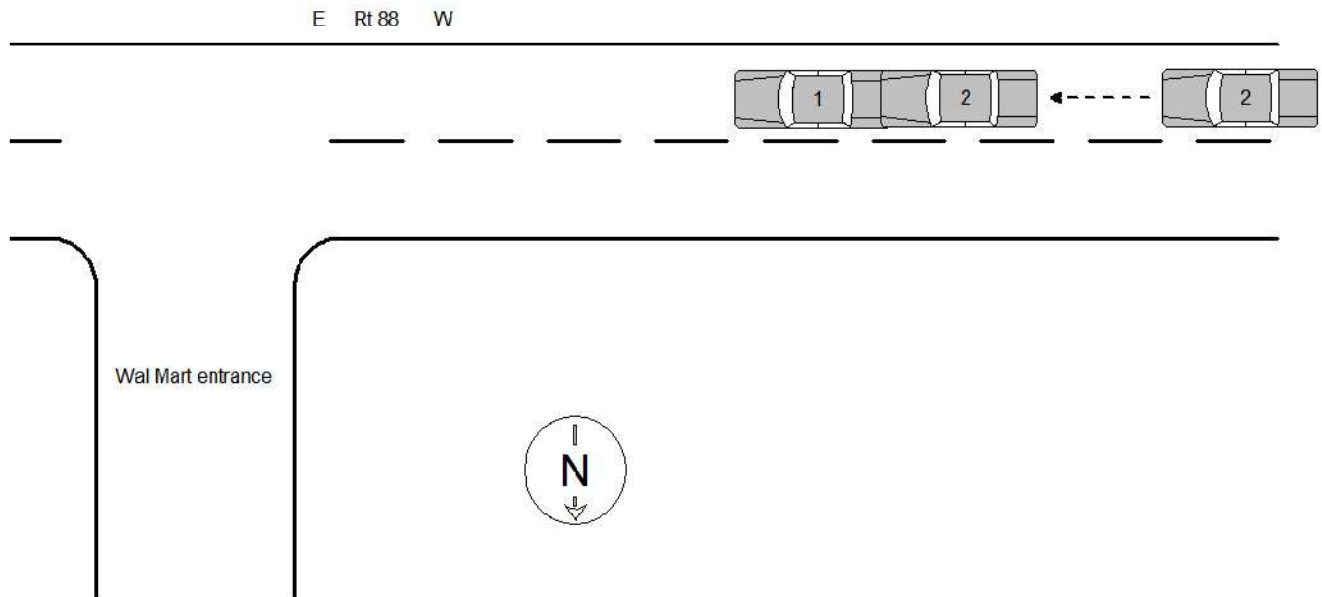
