145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 and Vehicle #2 were traveling on Van Zile Rd. in the area of Rt. 70.

Vehicle #1 was stopped to the rear of Vehicle #2 in the right hand lane waiting on the red traffic signal to cross over Rt. 70. The left turn only arrow illuminated green and Vehicle #1 began in traffic. Vehicle #2 remained stopped at the red light for traffic heading across Rt. 70 and Vehicle #1 struck the rear of Vehicle #2.

Driver of Vehicle #1 advised she was stopped to the rear of Vehicle #2 on Van Zile Rd. when she observed the left turn arrow illuminate green. Driver of Vehicle #1 stated she believed it was a green light for both lanes and began to start in traffic. Driver of Vehicle #1 relayed she struck the rear of Vehicle #2.

Driver of Vehicle #2 advised she was stopped at the red traffic signal on Van Zile Rd. when Vehicle #1 struck the rear of her vehicle.

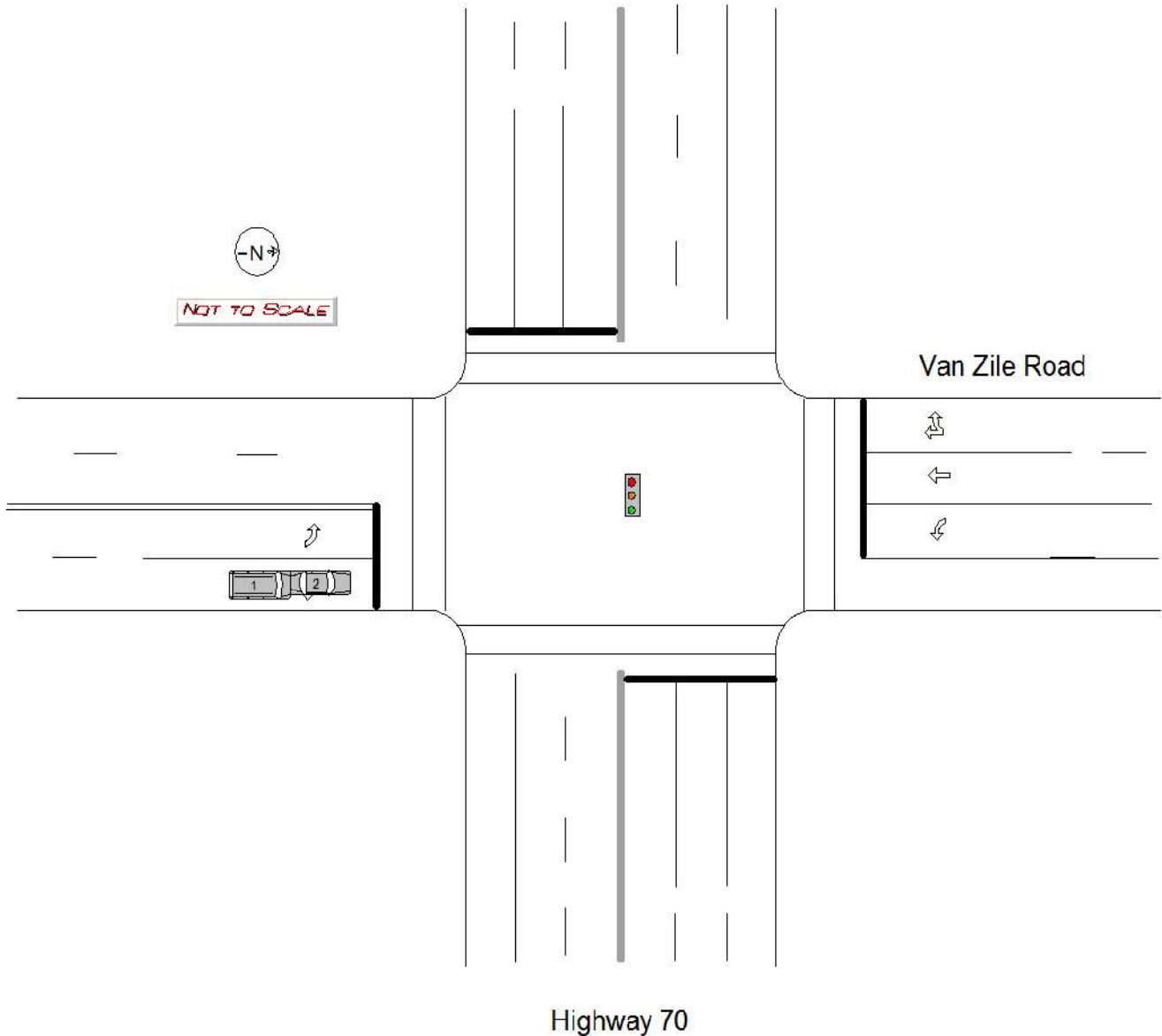
