145. Crash Description/Narrative

Vehicles 1 and 2 were located in the parking lot of 495 Jack Martin Boulevard. Vehicle 1 was legally parked in the first handicap parking space closest to the front doors of Ocean Pulmonary Group. Vehicle 2, a wheelchair transport bus owned and operated by Ocean Ride of Ocean County pulled behind Vehicle 1 to lower its side-loading lift for a patient in the drop-off/loading area at the sidewalk apron.

As the driver of Vehicle 2 stood alongside the lift as it was being lowered beside the bus, the driver of Vehicle 1 was unaware of what was going on behind his car. The driver of Vehicle 1 then backed into the wheelchair lift at low speed while the lift was being lowered. There were no persons on the lift at this time, and the bus driver was clear of the accident.

There was no visible damage to the wheelchair lift, and it operated normally afterwards. Vehicle 1 sustained as crack to its right rear tail light.

No injuries were reported at the scene. Cosmetic damage only. Both vehicles were driven from the scene and no motor vehicle summonses were issued.

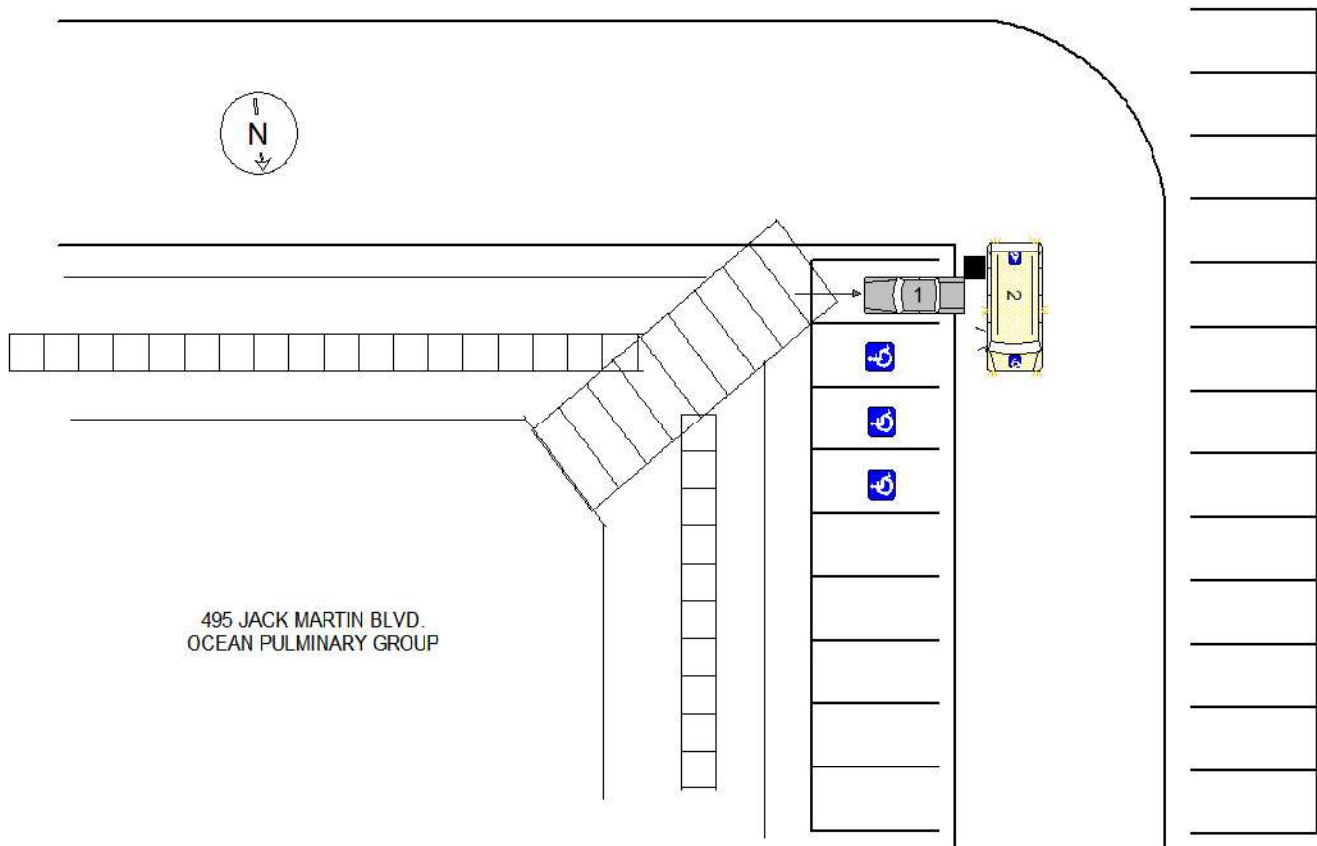
