145. Crash Description/Narrative

Vehicles 1 and 2 were traveling northbound on Burrsville Road, approaching the intersection of Jack Martin Boulevard. Vehicle 1 was behind Vehicle 2.

Driver of Vehicle 2 stated he then began to slow to a speed of approximately 25 mph for a line of slow moving traffic ahead. Driver of Vehicle 2 stated that he was then struck from behind by Vehicle 1.

Driver of Vehicle 1 stated that she did observe Vehicle 2 slow for the traffic ahead, but when she applied her brakes, the vehicle slid forward into the rear of Vehicle 2.

No injuries were reported at the scene. Vehicle 1 was towed by Sandy's Service Center due to disabling front end damage. Vehicle 2 was able to be driven from the scene. No motor vehicle summonses were issued. Investigation at the scene determined Vehicle 1 to be at fault for the collision.

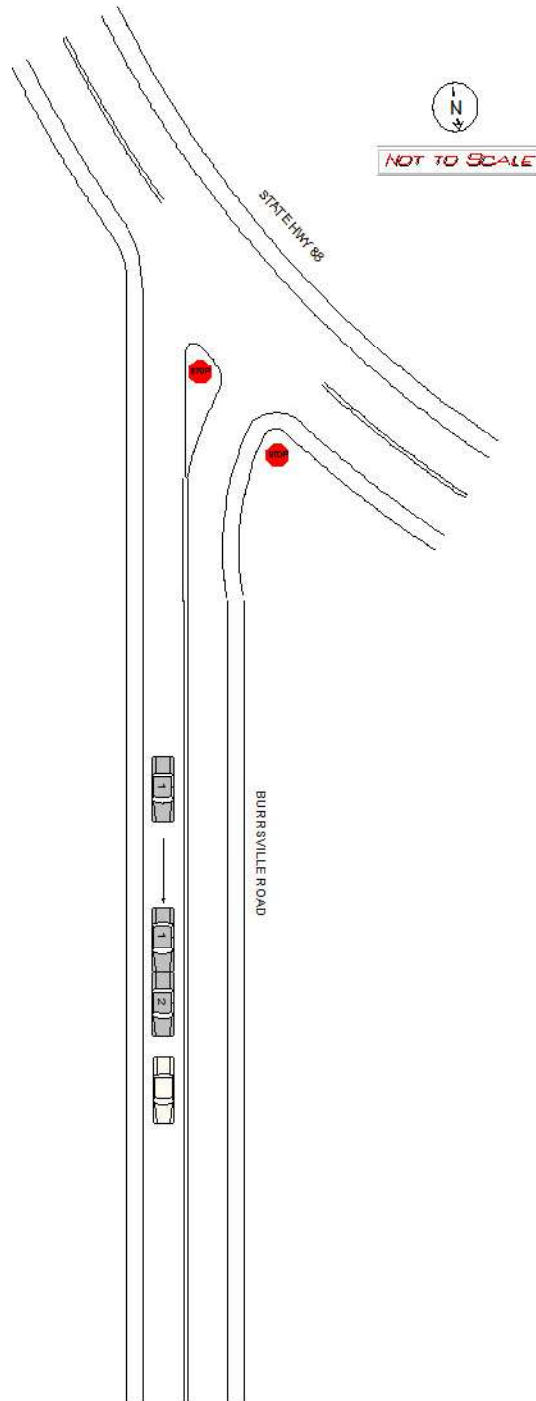
