145. Crash Description/Narrative

Driver of vehicle #1 was backing up North in the parking lot of 425 Jack Martin Blvd. (Brick Hospital) and struck vehicle #2. Vehicle #2 was unoccupied parked facing West in the parking lot when it was struck by vehicle #1.

Driver of vehicle #1 stated he was backing up out of a parking space attempting to back into another space when he misjudged his distance and struck vehicle #2. He stated he saw the vehicle, however thought he had enough distance to back up safely.

My investigation revealed driver #1 did not have enough distance between his vehicle and vehicle #2 while he was backing up, subsequently causing him to strike vehicle #2 which was parked.

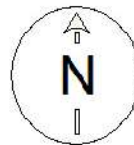
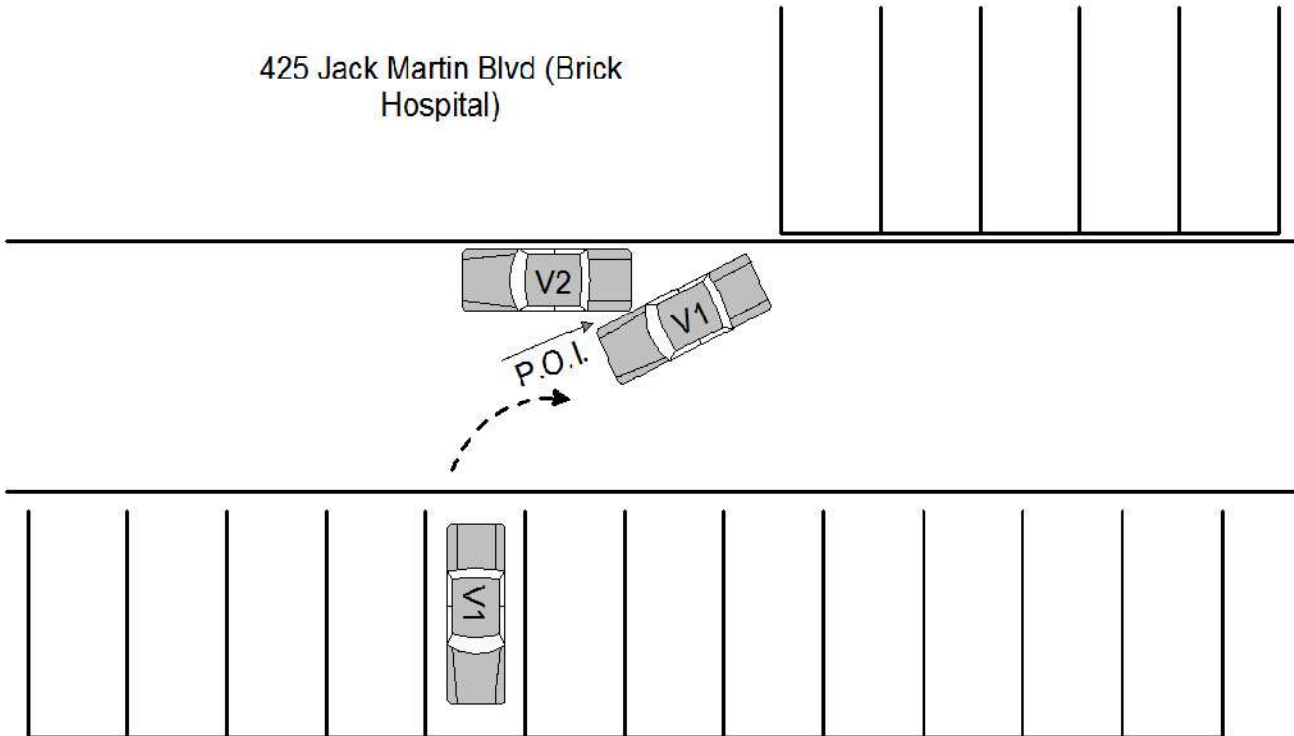
