145. Crash Description/Narrative

Vehicle 1 stopped in traffic, right lane of Van Zile Road southbound, approaching Route 70. Vehicle 2 stopped directly behind Vehicle 1.

Driver 2 stated traffic was stopped, waiting for the traffic light to turn green. As the light turned green, Vehicle 1 began backing up. Driver 2 stated she continuously sounded her horn until Vehicle 1 struck the front end of her vehicle.

Driver 1 stated he was stopped waiting for the traffic light to change. When the light changed, he saw the drivers of two unknown vehicles in front of him exit their vehicles. Driver 1 stated he began to back up, so he could drive around the stopped vehicles. Driver 1 stated he never saw Vehicle 2 stopped behind him until he struck it.

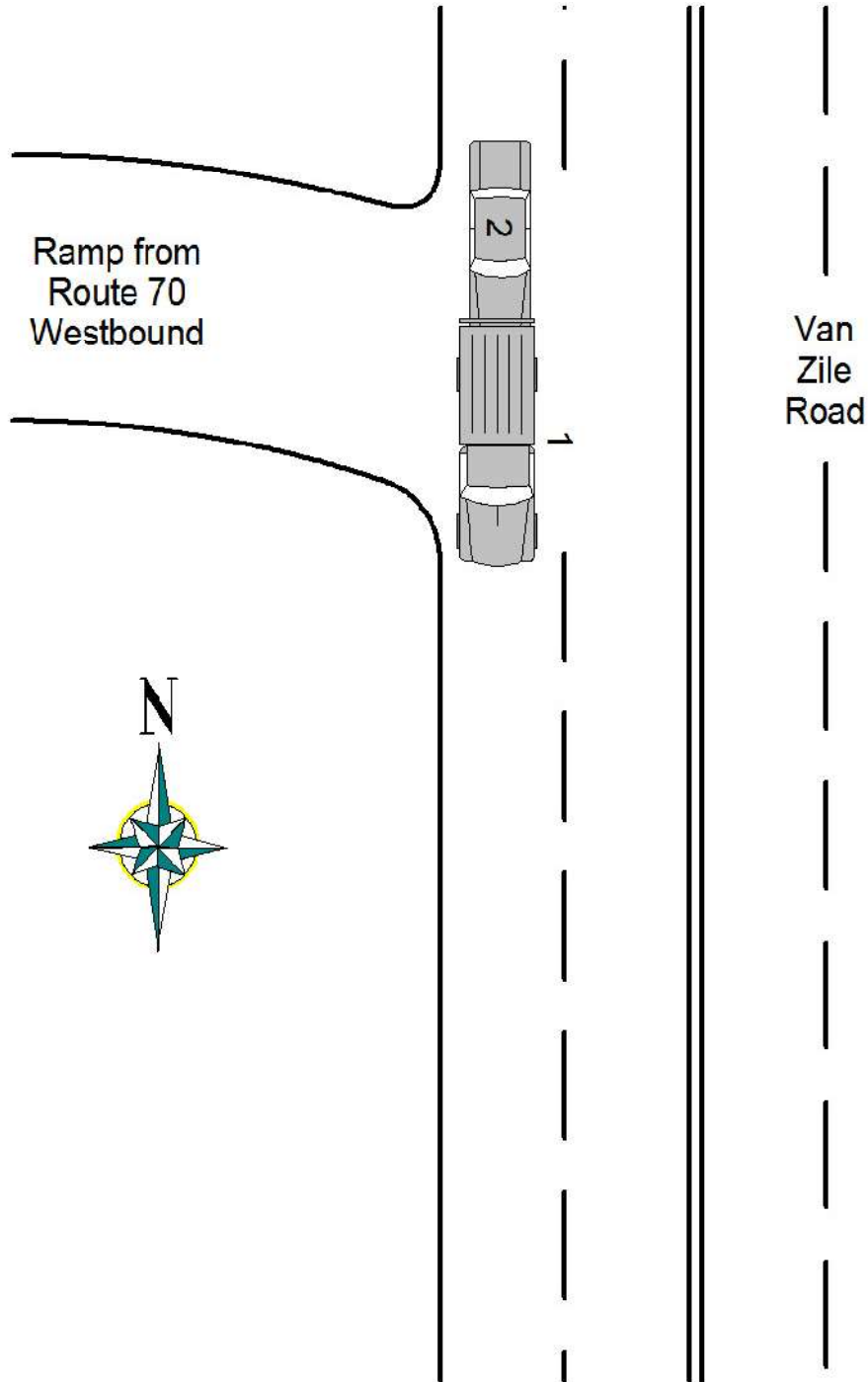
