145. Crash Description/Narrative

Vehicle 1 was stopped with a red light at the intersection of Route 70 and Van Zile Road facing south. Driver 1 observed the green right turn only signal and accelerated into the rear of vehicle 2 which caused vehicle 2 to strike the rear of vehicle 3.

Driver 1 stated the following:

She observed the green arrow signal for the right turn only and mistakenly thought she could proceed through the intersection. She struck the rear bumper area of vehicle 2 with the front bumper area of her vehicle.

Driver 2 stated the following:

She was stopped at the intersection of Van Zile and Rt 70 when her vehicle was struck from behind by vehicle 1 which caused her vehicle to strike the rear bumper area of vehicle 3.

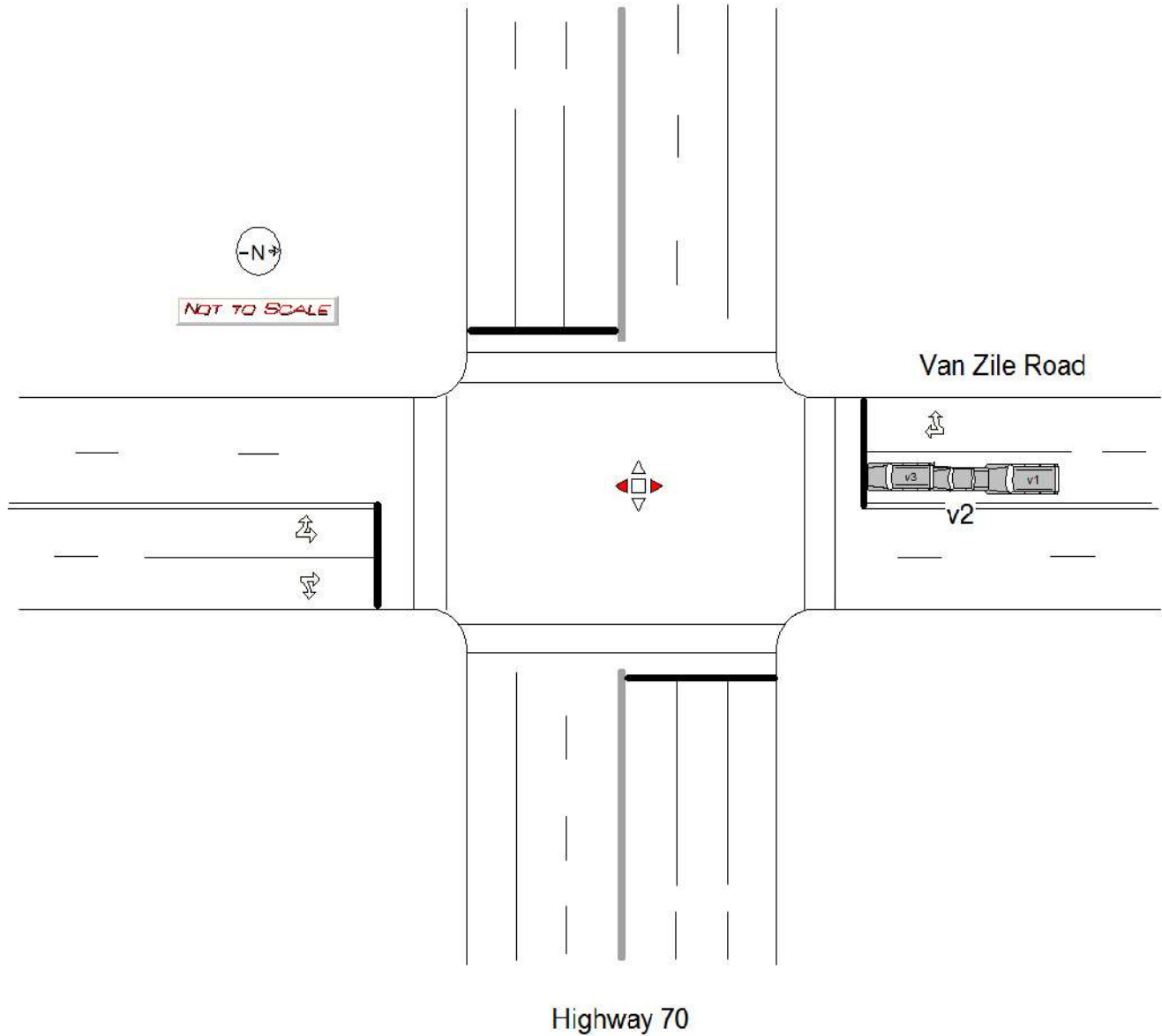
