145. Crash Description/Narrative

Vehicle 2 stopped in the left lane of Route 88 westbound, just prior to Route 70. Vehicle 1 stopped directly behind Vehicle 2.

Driver 2 stated he was stopped in traffic, waiting for a green traffic light. Driver 2 stated the light had turned green and the vehicle in front of him did not move. Driver 2 stated he sounded his horn to alert the unknown vehicle and before they began to move, he was struck from behind by Vehicle 1.

Driver 1 stated he was stopped behind Vehicle 2 for the red traffic light. Driver 1 stated the light had turned green and he rolled into the rear of Vehicle 2.

Vehicle 2 had minor damage to the rear bumper area and Vehicle 1 had no visible damage to the front end.

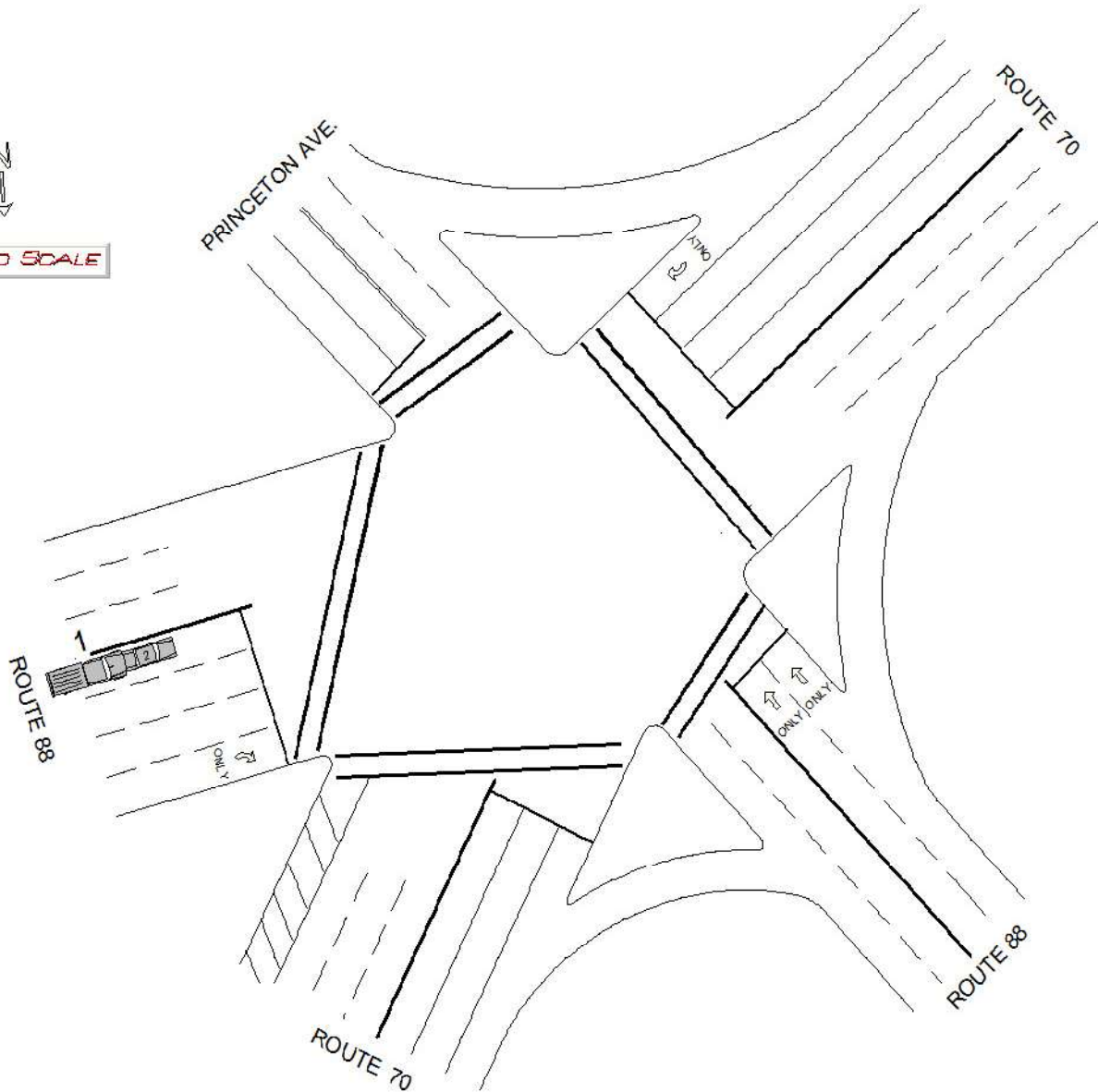
