145. Crash Description/Narrative

Vehicle #1 was making a left turn onto Jack Martin Blvd out of the doctor's office plaza at 495 Jack Martin Blvd. Vehicle #2 was traveling South on Jack Martin Blvd. Driver #1 pulled out in front of Vehicle #2, causing disabling damage to both vehicles.

Driver #1 advised that she initially stopped and looked both ways before attempting the turn. Driver #1 stated she saw Vehicle #2 coming but believed she had enough time and distance to make the turn, advising that Driver #2 must not have been paying attention.

Driver #2 advised that he was traveling straight when he observed Vehicle #2 begin inching out into the roadway. He advised that Driver #1 was looking to her right and never looked to the left while attempting the turn. Driver #2 further stated that he applied his horn and brakes but did not have enough time to avoid the collision.

Witness #1 advised that Driver #1 initially pulled out in front of her and cut her off in the parking lot before approaching the stop sign at Jack Martin Blvd. Witness #1 stated she was then directly behind Vehicle #1

at the exit, and stated that Driver #1 never completely stopped and then pulled out in front of Vehicle #2 that was traveling at the normal rate of speed before suddenly applying his brakes. Witness #1 stated that Driver #2 never had enough time to avoid the collision.

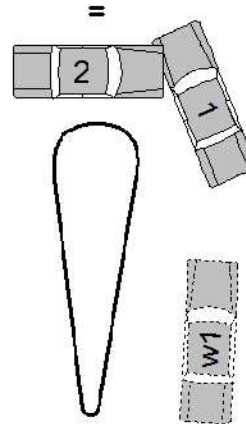
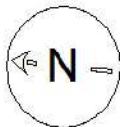
