145. Crash Description/Narrative

Vehicle #2 eastbound State Highway 70 changed lanes from left to right lane, then made evasive maneuver and collided with Vehicle #1. Vehicle #1 westbound in eastbound lane was struck by vehicle #2. Driver #2 stated that he changed lanes from the left to the right and did not observe vehicle #1 with plow in right lane prior to lane change, when he realized that the vehicle was in the lane he attempted to avoid it but was unable and collided with vehicle #1. Driver # 1 stated that his vehicle was facing eastbound, driver #2 attempted to enter parking lot and collided with his vehicle causing it to spin around and face the position depicted in diagram. Driver #1 stated to Ptl. Gannaio #234 who was assisting with traffic control, that he did not move the vehicle after the crash and it is in the position it was when it was struck. Driver's #1 and 2 stated that they were not injured, however, Driver #2 initially stated he was unsure if he was injured, was evaluated by first aid, and refused any further treatment.

Phillip Della-Pietro stated that he was operating his vehicle bearing NJ license plate ZSH15G directly behind vehicle #2 and stated that vehicle #2 changed lanes from left to right and then observed vehicle #1 and attempted to move back to left lane, but collided with vehicle #1. Della-Pietro completed a Motor Vehicle Crash Witness Statement.

Driver #1 was conducting snowplow operations in The Shoppes At Brick and was not authorized by NJDOT to plow
