145. Crash Description/Narrative

Vehicle #2 stopped at red traffic signal. State Highway 70 westbound was struck by vehicle #1. Vehicle #1

Directly behind vehicle #2 stopping for red traffic signal collided with vehicle #2. Driver #1 stated that she

was attempting to stop for traffic signal and struck vehicle #2. Driver #2 stated that he was stopped for a red

traffic signal and was struck by vehicle #1. Driver #1 stated that she was not injured. Driver #2 had a complaint

of pain to his neck, right shoulder, and back (center and lower right). driver #2 refused First Aid. Driver #1

failed to observe vehicle #2 in roadway and collided with it.

The roadway was wet, had patches of ice, and had been salted/sanded prior to crash.

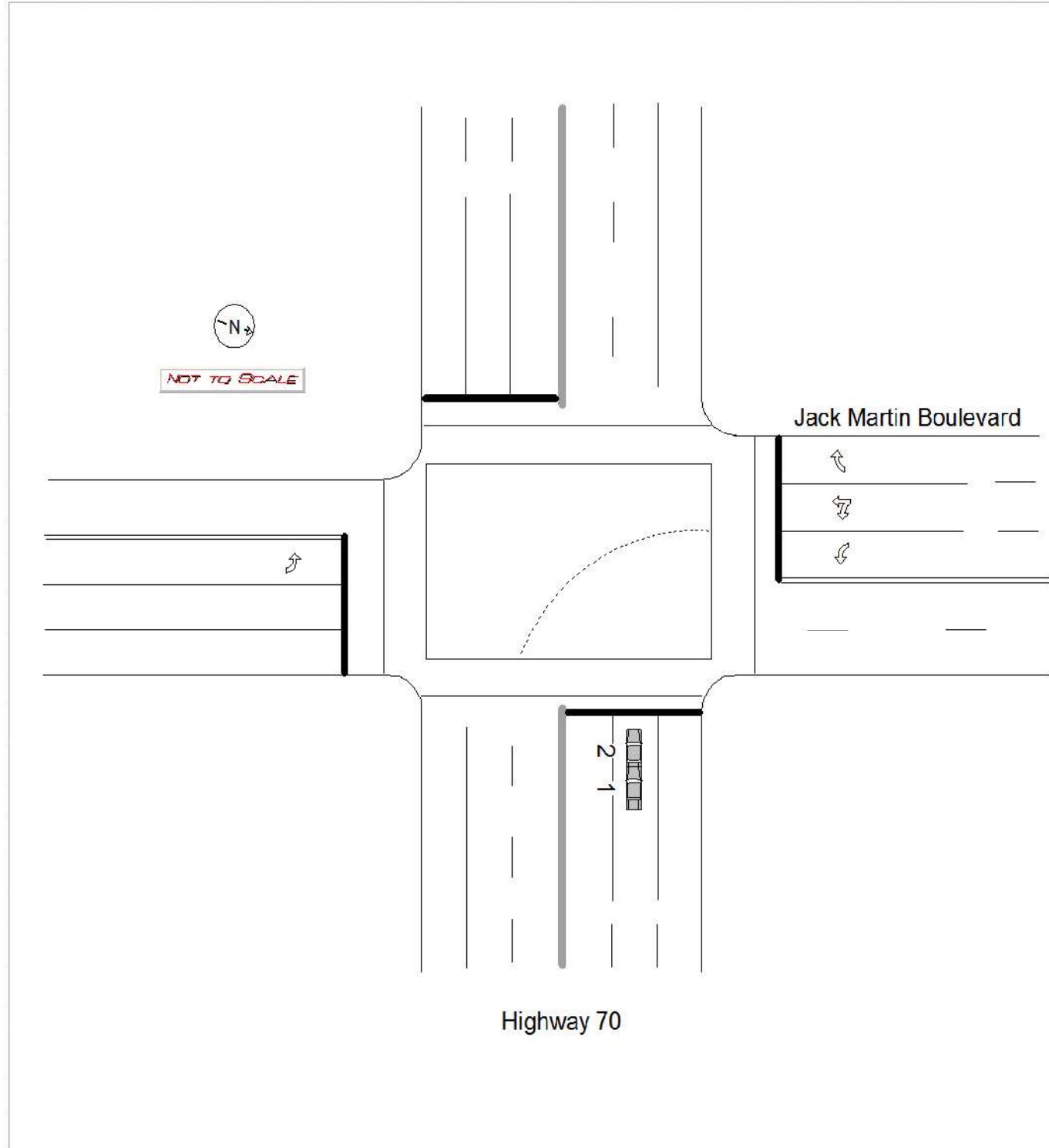
