145. Crash Description/Narrative

Vehicle 1 was traveling east on Route 88 in the area of 2004 Route 88 at a high rate of speed. Vehicle 1 lost control crossed the center line, exited the road to the left, struck a traffic sign, some branches, a white picket fence on the property of 2004 Route 88, the business sign for 2004 Route 88, Utility Pole BK 265, and then overturned and coming to final rest in the west bound travel lane of Route 88.

The driver of Vehicle 1 stated he was traveling east on Route 88. The driver of Vehicle 1 stated he was traveling above the speed limit when he looked away from the road and lost control of the vehicle, striking the business sign for 2004 Route 88, Utility Pole BK 265, and his car overturning.

Vehicle 1 was at final rest upon my arrival. The Driver of Vehicle 1 had a laceration to his left hand, but refused medial attention. Vehicle 1 was towed from the scene by Joe's Service Center. The Driver of Vehicle 1 was issued summons E18-000016 for 39:4-97, Careless Driving.

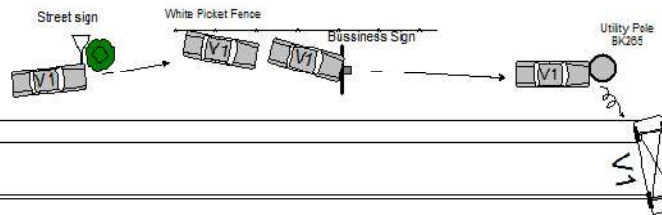
