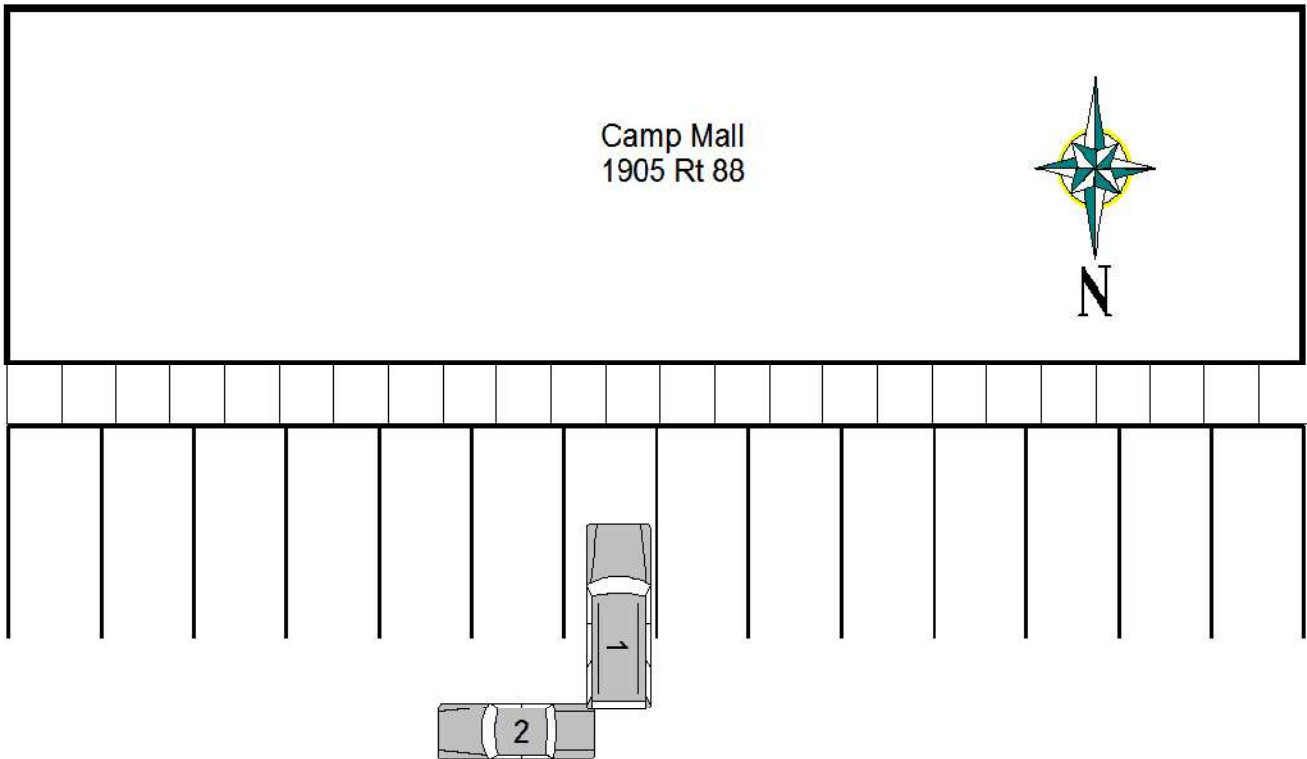
Driver 1 stated she was backing out of her parking space using the vehicle's rear view camera and did not see Vehicle 2 stopped behind her.
