145. Crash Description/Narrative

Vehicle 1 and vehicle 2 were traveling east on Route 88 taking the ramp onto Route 70 west. Vehicle 1 rear ended vehicle 2 at the yield sign.

Driver 1 states she was behind vehicle 2 east on Route 88 taking the ramp onto Route 70 west. Driver 1 stated she thought vehicle 2 had proceeded into traffic and she looked to see if there was traffic on Route 70 as she began to proceed through the ramp. Driver 1 stated when she looked back ahead vehicle 2 was stopped. Driver 1 stated she could not stop in time and rear ended vehicle 2. I observed a small crack to the front bumper of vehicle 1.

Driver 2 stated he was travel east on Route 88 taking the ramp onto Route 70 west when he stopped at the yield sign for traffic traveling on Route 70. Driver 2 stated while stopped waiting for traffic vehicle 1 rear ended him. I observed a small hole along with a minor crack in the rear bumper of vehicle 2.

Investigation revealed that the crash was due to driver 1 following too close behind vehicle 2.

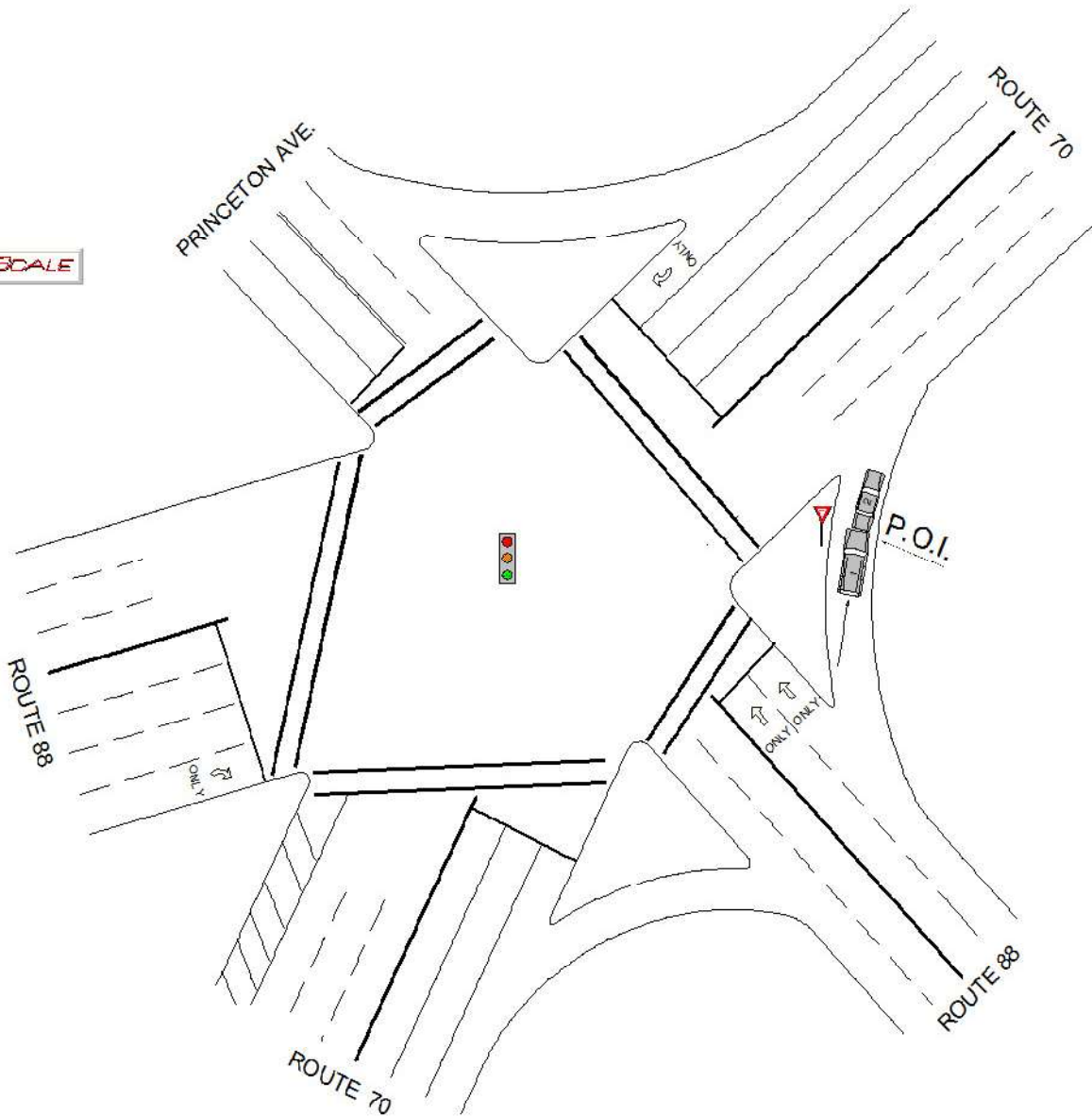
