145. Crash Description/Narrative

During my investigation, Vehicle #1 had minor damage to the right rear bumper. Vehicle #2 had a right cracked headlight.

Driver #1 explained he just finished filling up his truck from the gas station and began to exit the gas station. Driver #1 stated traffic was built up on Route 88 and could not make the right turn.

Driver #1 backed up to be able to negotiate the turn. As he backed up he observed vehicle #2 too close to him causing him to back up into vehicle #2.

Driver #2 explained he was behind vehicle #1. Once vehicle #1 finished filling his truck He began to pull up to the gas pump. As he started to pull up to the gas pump he observed vehicle #1 backing up.

He honked his horn but it did not have any affect to vehicle #1. Vehicle #1 backed into his vehicle causing minor damage to his headlight.

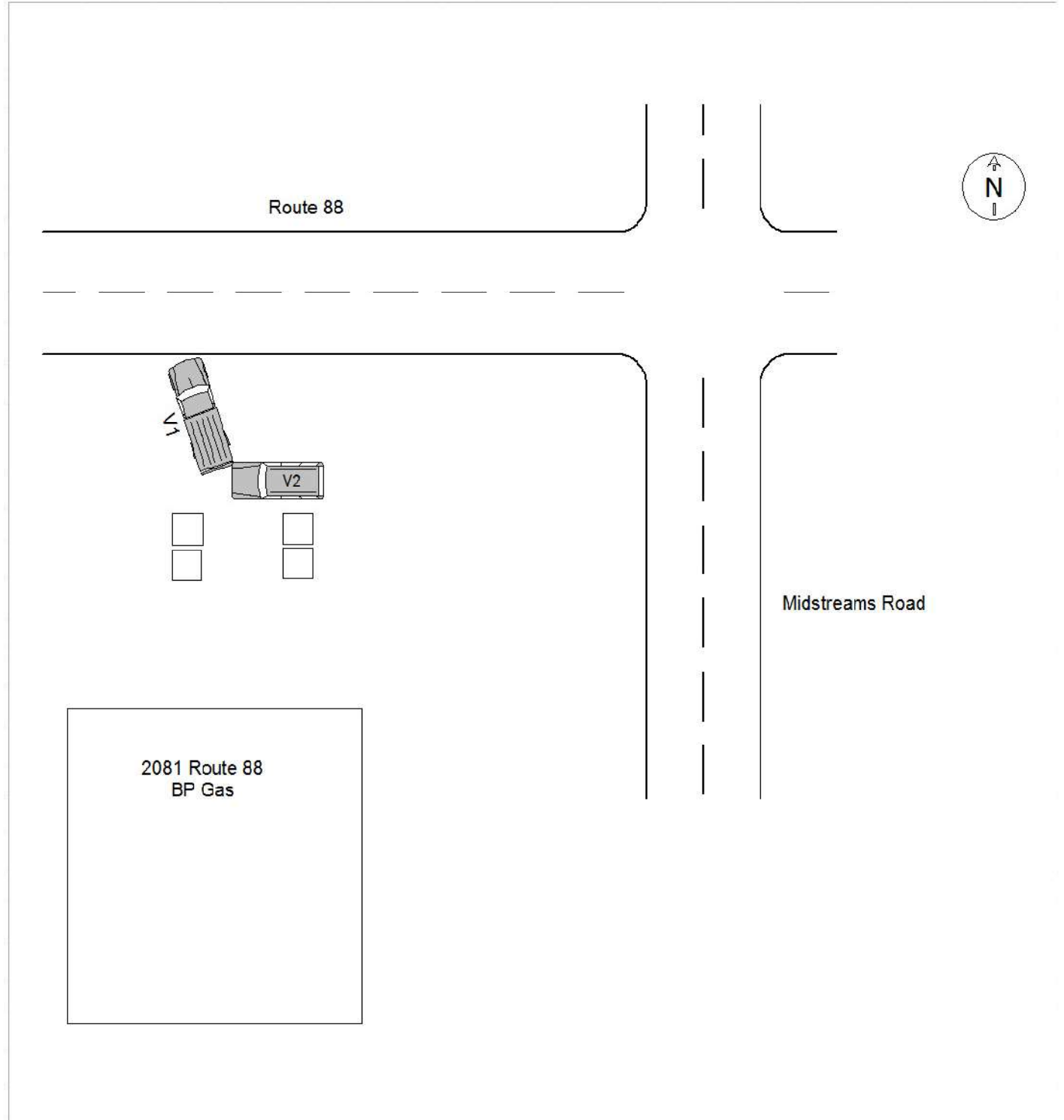
