145. Crash Description/Narrative

Vehicle 2 stopped in traffic, Jack Martin Boulevard southbound just prior to Route 70. Vehicle 1 stopped in traffic directly behind Vehicle 2.

Driver 2 stated she was stopped waiting for the traffic light to change. When the light turned green, Driver 2 stated she was struck from behind by Vehicle 1.

Driver 1 stated she was stopped waiting for the traffic light to change. When Driver 1 saw the light turn green, she started to go, striking the rear of Vehicle 2. Driver 1 stated she did not know what she was thinking when she started to accelerate before traffic started moving.

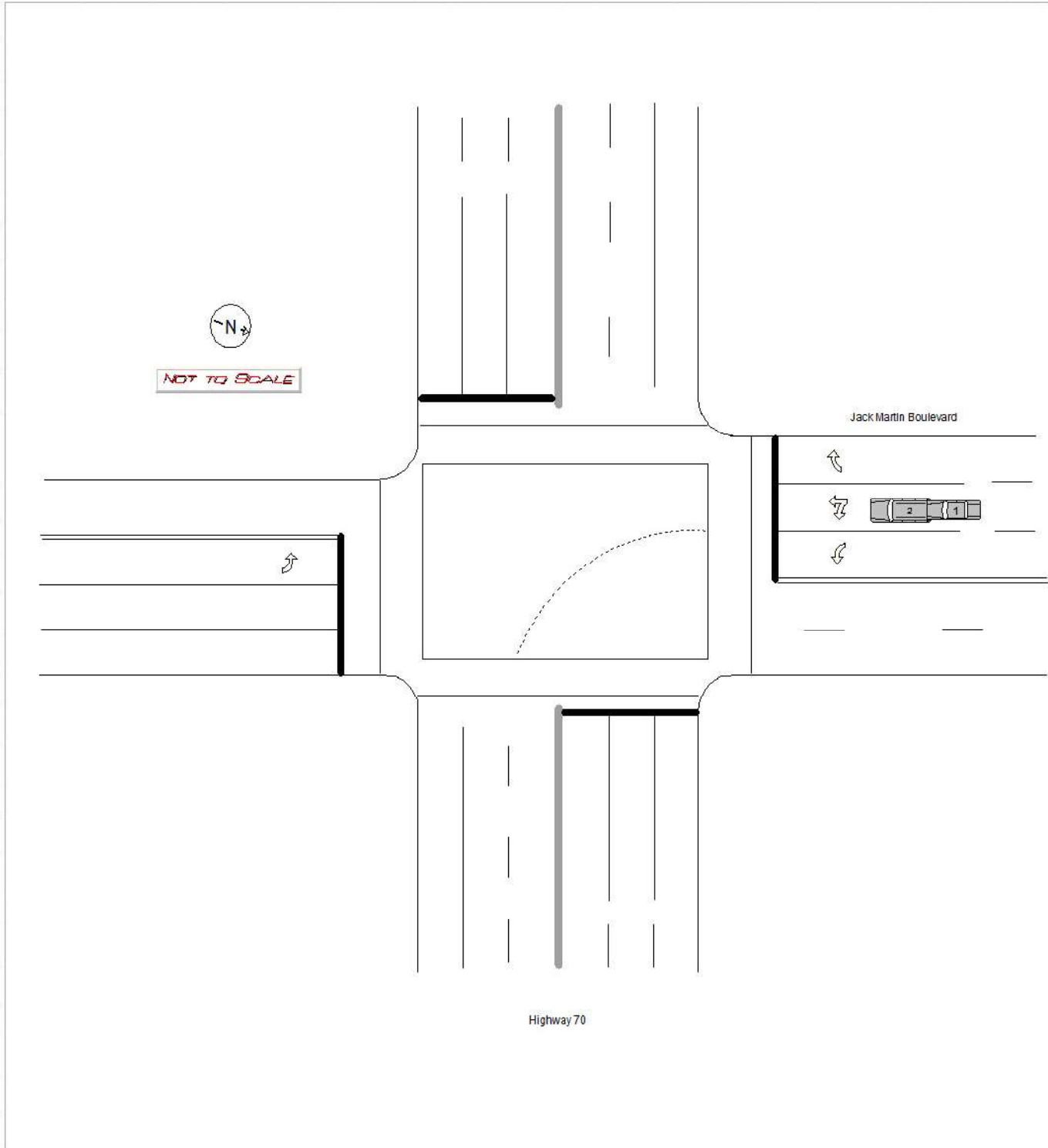
