145. Crash Description/Narrative

Vehicle 1 was exiting the parking lot of 1937 Route 88, turning left onto Route 88 Westbound. Vehicle 2 was traveling East on Route 88, approaching the exit of 1937 Route 88. The front bumper of Vehicle 1 impacted the rear passenger side door of Vehicle 2.

The operator of Vehicle 1 stated she was attempting to pull out onto Route 88 from the exit of the parking lot.

The operator of Vehicle 1 stated she was observing Westbound traffic while entering the roadway, and did not observe Vehicle 2 traveling in the Eastbound lane. The operator of Vehicle 1 stated when she observed the Westbound traffic lane was clear, she entered the roadway and struck Vehicle 2. The operator of Vehicle 1 stated she was attempting to make a left turn during heavy traffic volume.

The operator of Vehicle 2 stated he was traveling East on Route 88 and observed Vehicle 1 in the shoulder, directly in front of the exit to the parking lot. The operator of Vehicle 2 stated as he was passing the parking lot exit, Vehicle 1 pulled out and struck the passenger side of his vehicle.

Both vehicles were moved prior to my arrival and no injuries were reported. Vehicle 1 appeared to be leaking

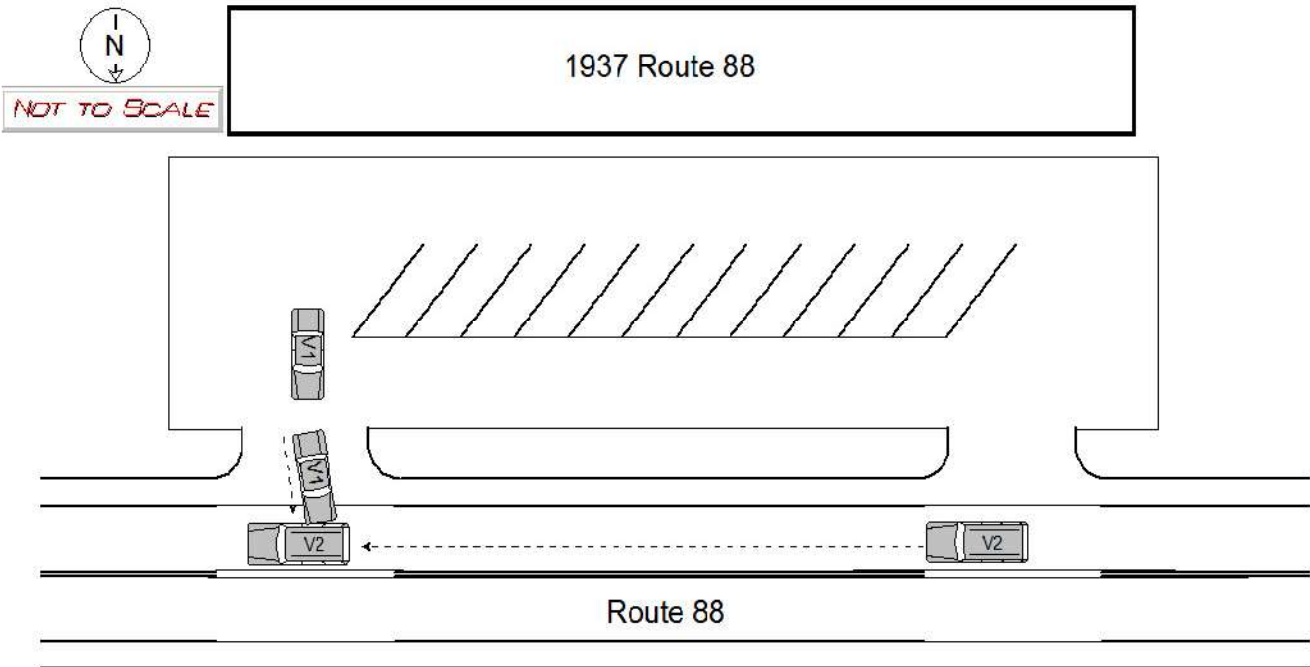
