145. Crash Description/Narrative

Driver 2 stated she saw 2 ambulances with their lights and sirens engaged about to cross route 70 in an attempt to
continue down Jack Martin Blvd. Believing their was an emergency she stopped just prior to the intersection and
was then stuck in the rear by vehicle 1.

Driver 1 stated he was traveling in the middle lane of route 70 as he approached the intersection of Jack Martin
Blvd which had a green traffic signal. Before the intersection driver1 recalls seeing 2 ambulances with their
lights and audible's engaged to his right. He advised he looked over to them for a moment and upon returning his
vision back to the roadway he was about to strike vehicle 2. Unable to stop in time, he crashed into the rear of
vehicle 2.

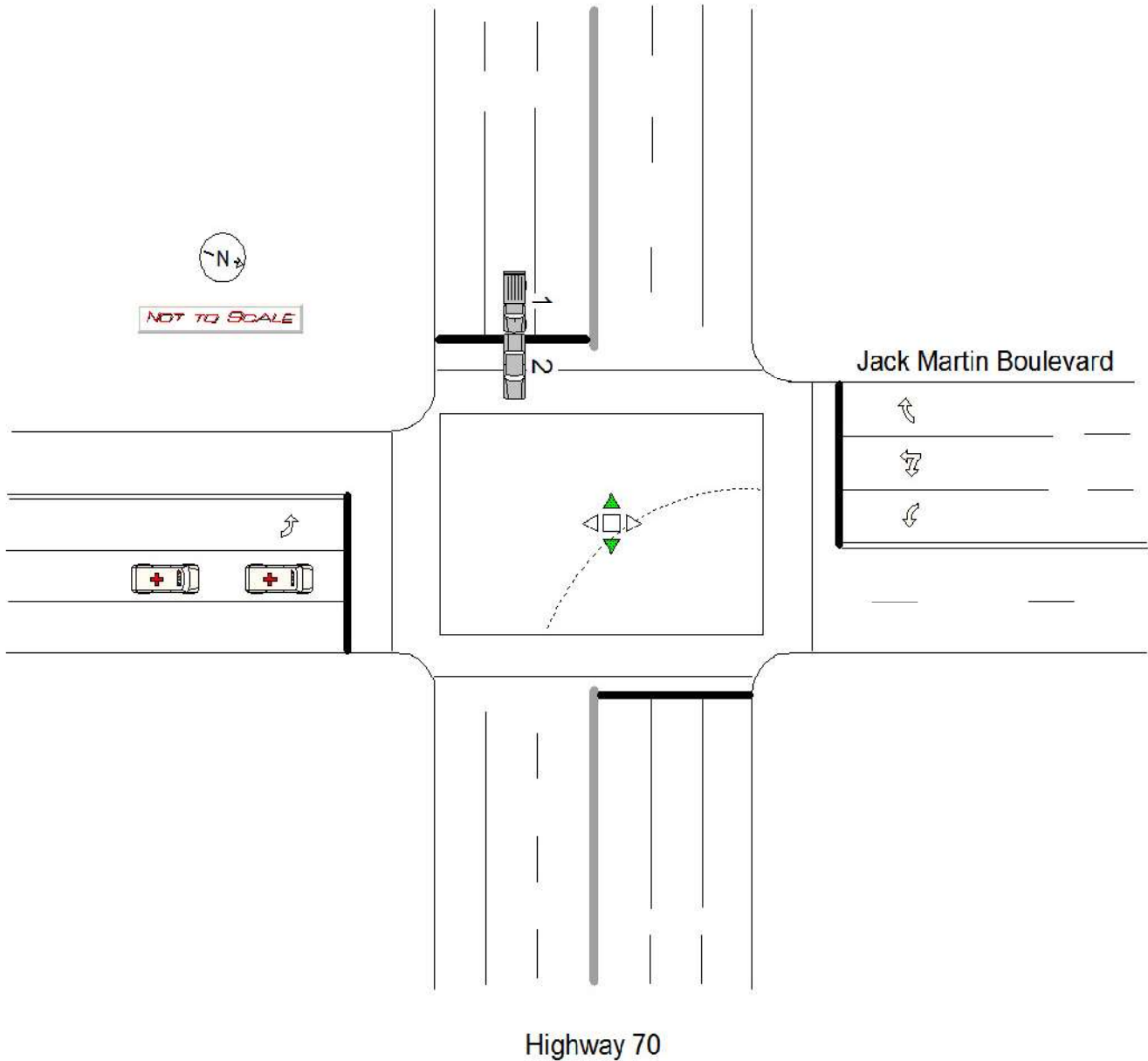
