145. Crash Description/Narrative

On scene investigation revealed that vehicle 1 was traveling east on Rt 88 approaching Jack Martin Blvd while vehicle 2 was traveling north on Jack Martin Blvd approaching the intersection of Rt 88. Vehicle 1 executed a right hand turn at which time the driver lost control of the vehicle resulting in the collision with vehicle 2.

The drivers provided the following statements:

Driver 1 stated he was approaching the intersection of Rt 88/Jack Martin Blvd with a green light illuminated. Driver 1 made a right turn at which time he lost control of the vehicle due to it being rear wheel drive and struck vehicle 2. Driver 1 did not report any injuries on scene. Vehicle 1 had minor front end damage to the drivers side consisting of dents and scratches. Vehicle 1 was driven away from the scene.

Driver 2 stated he was approaching the intersection of Rt 88/Jack Martin Blvd with a red light illuminated. Driver 2 stated he was slowing down as he approached the traffic signal when he was struck by vehicle 1. Driver 2 did not report any injuries on scene. Vehicle 2 had minor rear end damage to the drivers side consisting of dents and scratches. Vehicle 2 was driven away from the scene.

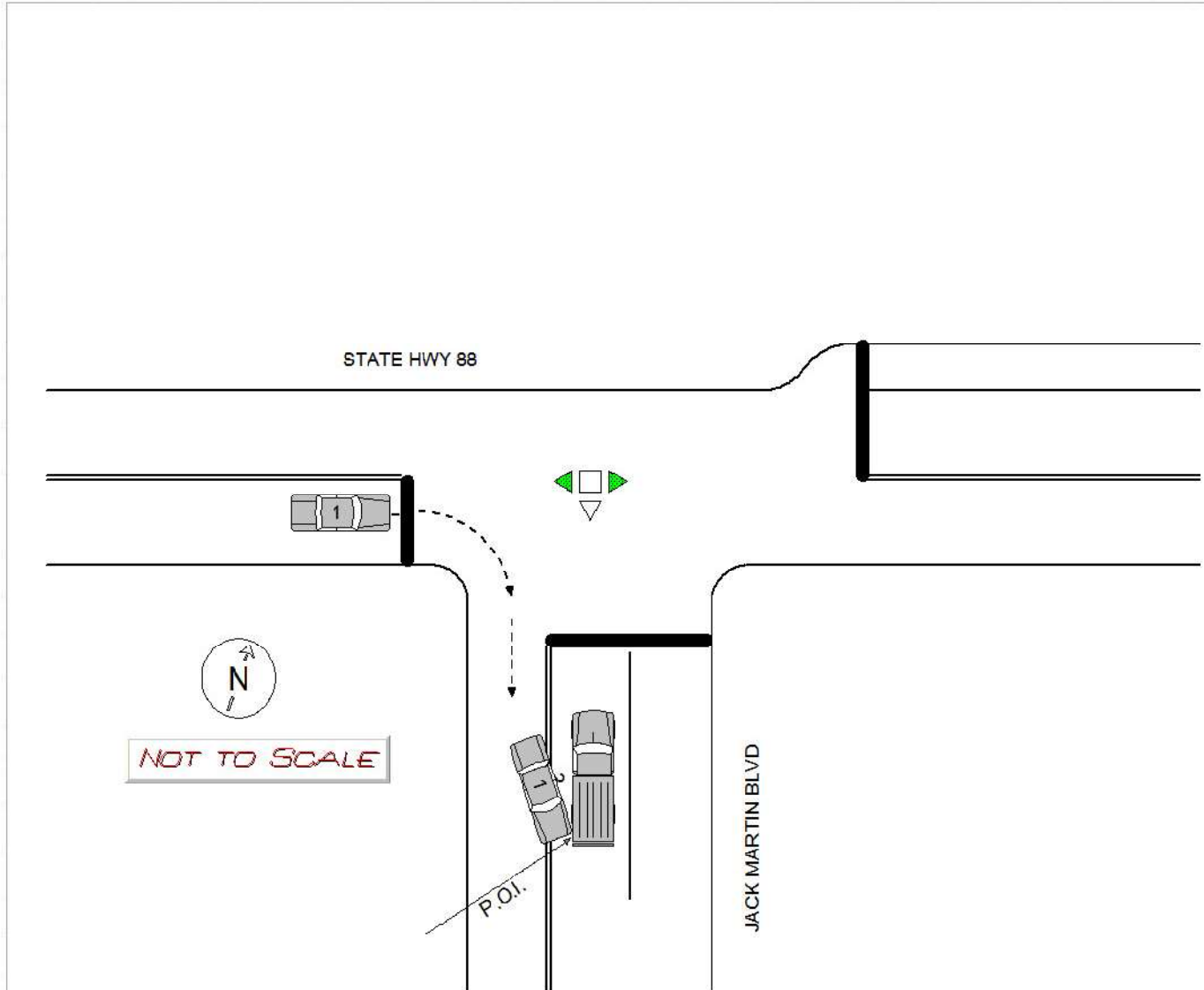
