145. Crash Description/Narrative

Vehicle 4 was stopped on Route 88 eastbound waiting for traffic. to turn left into the parking lot of 1930

Route 88. Vehicle 3 was stopped directly behind Vehicle 4. Vehicle 2 was stopped directly behind Vehicle 3 and

Vehicle 1 was traveling directly behind Vehicle 2.

Driver 4 stated she was stopped. waiting to make her turn and could see that Vehicle 3 was stopped behind

her. Driver 4 felt the impact of the Vehicle 3 striking the rear of her vehicle.

Driver 3 stated she was stopped behind Vehicle 4. waiting for her to complete her turn and could see Vehicle

2 stopped directly behind her. Driver 3 felt the impact of Vehicle 2 striking her from behind. pushing her into

Vehicle 4.

Driver 2 stated he was stopped waiting for traffic to move. Driver 2 saw Vehicle 1 approaching from a

distance. Driver 2 then felt the impact of Vehicle 1 striking the rear of his vehicle. pushing him into Vehicle

3.

Driver 1 stated he was traveling eastbound on Route 88. directly behind Vehicle 2. Driver 1 stated he did

not see the stopped vehicles and struck the rear of Vehicle 2, causing the chain reaction accident. Driver 1 stated he was talking with his passenger when the accident occurred.

The investigation revealed Driver 1 was engaged in a conversation with his passenger, which diverted his attention from driving. Driver 1 did not see the stopped vehicles and struck the rear of Vehicle 2. That caused the front of Vehicle 2 to strike the rear of Vehicle 3 and the front Vehicle 3 to strike the rear of Vehicle 4.

All the damage to the vehicles appeared to be minor and no one claimed any injuries.

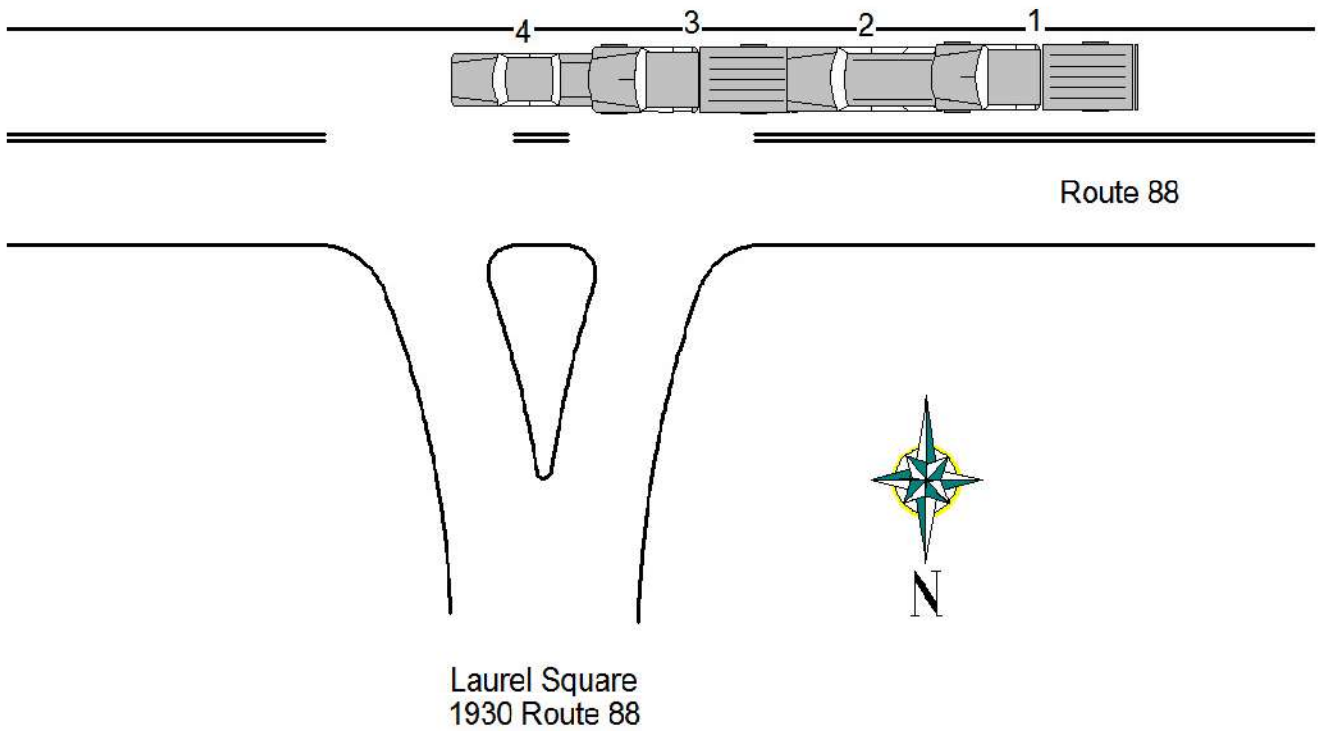
