145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 and Vehicle #2 were traveling in the left lane on Rt. 70 in the area of Olden St. Vehicle #2 was stopped in traffic when Vehicle #1 failed to stop and struck the rear of Vehicle #1.

Driver of Vehicle #1 advised he was traveling on Rt. 70 approaching Vehicle #2 which was stopped in traffic.

Driver of Vehicle #1 relayed as he was slowing his foot slipped of the brake pedal and he struck the rear of Vehicle #2.

Driver of Vehicle #2 advised she was stopped in traffic on Rt 70 when Vehicle #1 struck her vehicle in the rear.

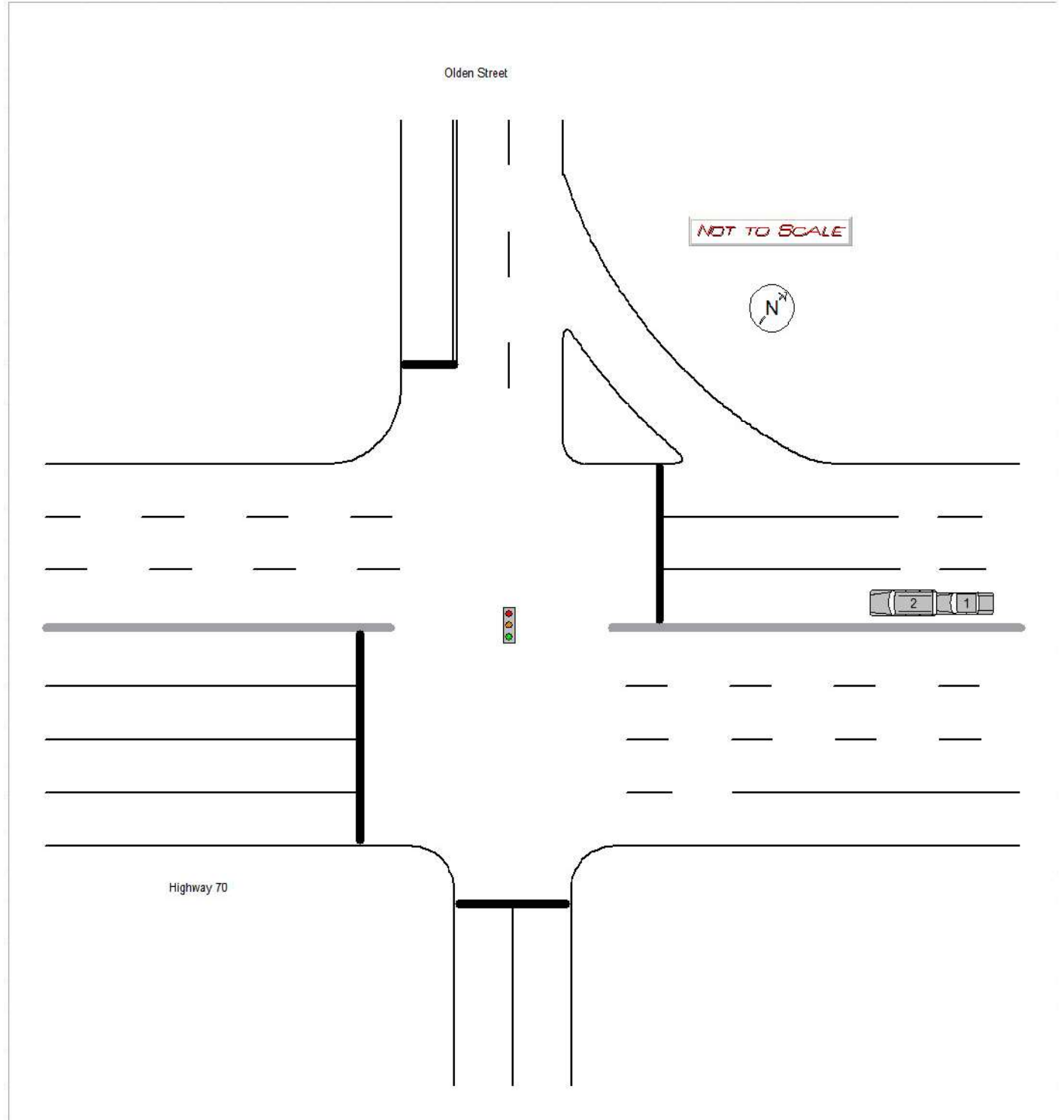
