of Route 88 / Coolidge Drive. While crossing the intersection, he related he was struck by V1. The rider of P2 related he was not paying attention as he crossed the intersection. Specifically, he was looking ahead at his older brother who was operating a bicycle directly in front of him.

The rider of P2 was not wearing a helmet at the time of the incident. The driver of V1 stated she was uninjured and declined first aid. The rider of P2 stated he was uninjured. However, Brick Medical Unit #535 arrived on location to check on his well-being and he / parents refused medical assistance. The parents / guardians of P2 arrived on location and took custody of him.

* A witness (Orlando Romano) remained on location and provided a statement. He also completed a Brick Township Police Department motor vehicle crash statement form, which was submitted with this report.

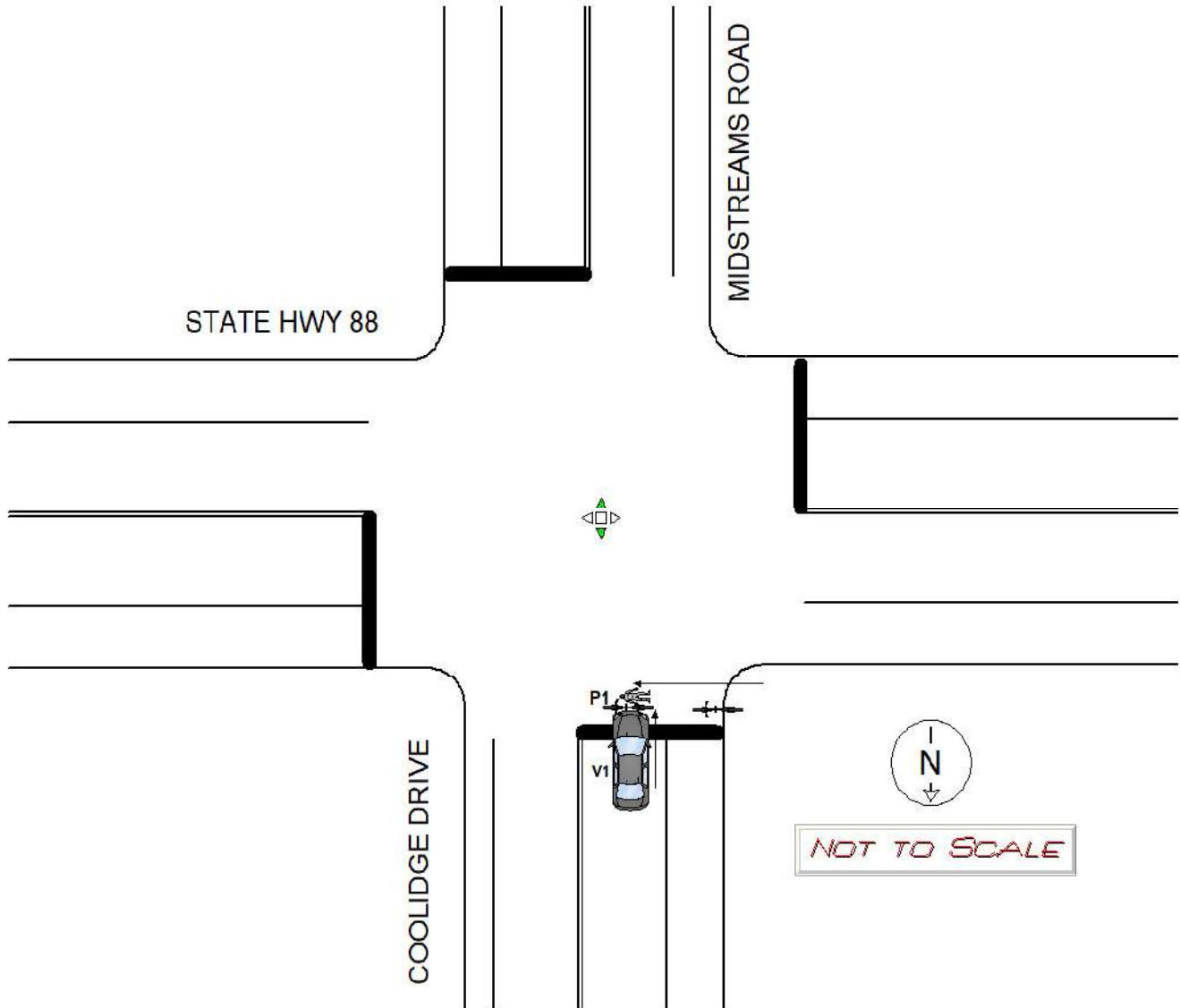
