145. Crash Description/Narrative

On October 30, 2021, I responded to Route 88 and Post Road for a motor vehicle crash. Upon arrival, I observed a black BMW with disabling front passenger side damage with multiple air bag deployment. I approached the driver who explained she was not injured. Driver #1 explained the following:

She was making a left hand turn from Post Road to Route 88 when she lost control of the vehicle. She believed the car hydro-planed causing her vehicle to slide into the traffic light. After striking the traffic light the traffic light fell onto her vehicle.

After getting both the driver and the passenger out of the vehicle Ptl. Bailey #293 arrived and conducted a Field Sobriety Test (see Ptl. Bailey #293 same case number).

Brick EMS 531 arrived on scene which both the driver and passenger refused medical treatment. Route 88 towing arrived and took the vehicle for John's Law.

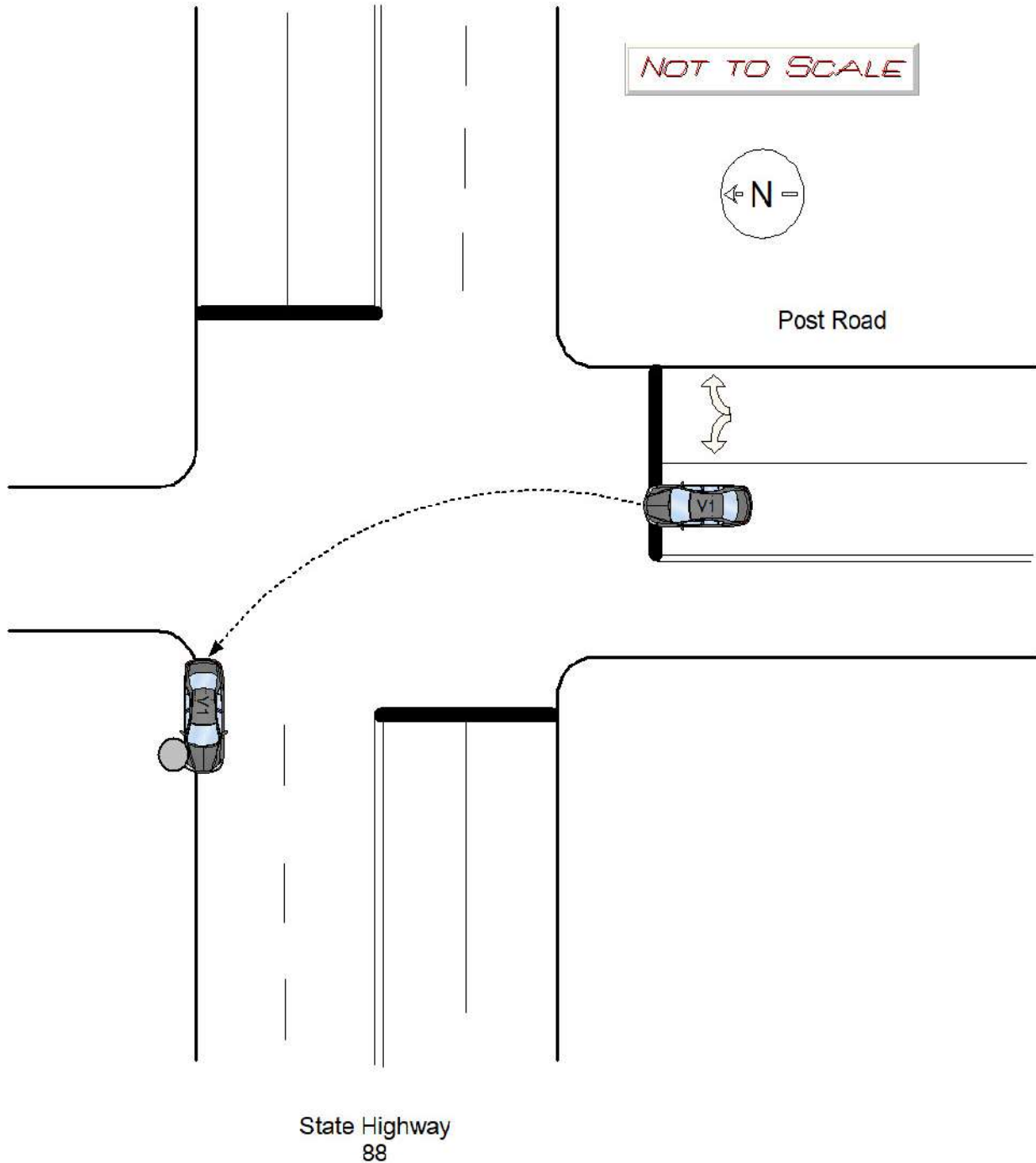
