145. Crash Description/Narrative

My investigation revealed the following: Vehicle 1 was stopped in traffic in the left turn lane on Jack Martin Blvd southbound approaching Route 70. Vehicle 2 was just behind vehicle 1 in the center travel lane on Jack Martin Blvd. Vehicle 1 attempted to merge into the center travel lane but, while doing so, contacted the rear left side of vehicle 2, causing paint transfer to both vehicles.

Driver 1 stated she was in the right travel lane with her left blinker on attempting to get into the middle travel lane. Driver 1 stated that the vehicle directly next to her moved up to give her space to move into the lane. Driver 1 advised that once the light turned green, vehicle 2 pulled quickly in front of her, causing her front right side to sideswipe vehicle 2's left rear side.

Driver 2 stated he was waiting at the light to cross the intersection. Driver 2 advised vehicle 1 did not have a blinker on. Driver 2 stated once the traffic light turned green, he started to move forward, and his vehicle was approximately three-quarters past vehicle 1, then attempted to merge into his lane.

No injuries were reported at this time. Both drivers were provided with a copy of the case number. My department

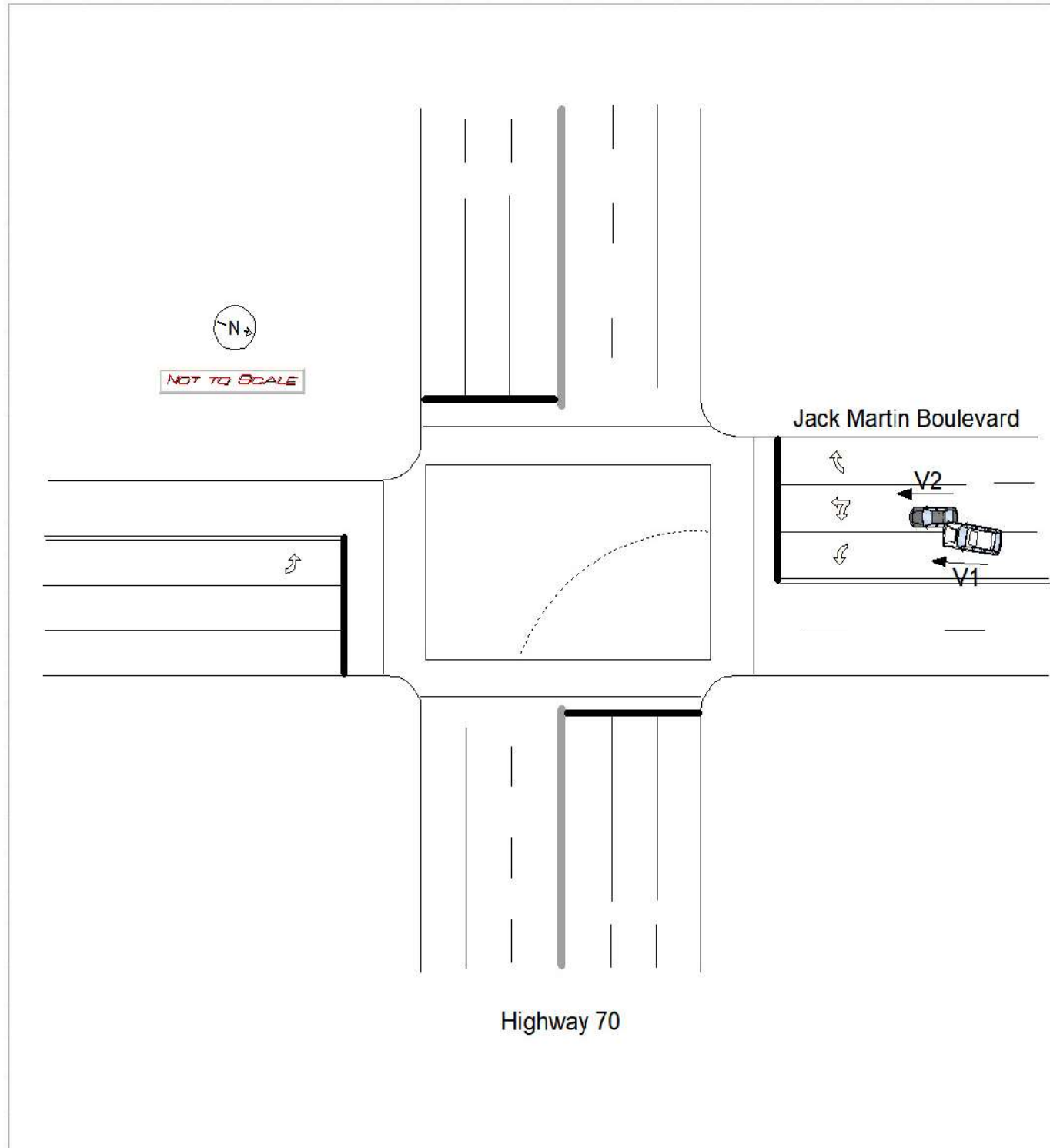
