145. Crash Description/Narrative

Vehicle #1 and #2 were traveling west on Route 70. Vehicle #2 began braking behind the vehicle in front of them.

Vehicle #1 also attempted to stop, but was following too close and struck the rear bumper of vehicle #2.

The driver of vehicle #1 stated she was traveling on Route 70 behind vehicle #2. Vehicle #2 began to stop in traffic. She then began to brake also, but was too close to the other vehicle and struck the rear bumper, with the front bumper of her vehicle.

The driver of vehicle #2 stated she was slowing down in traffic on Route 70. While slowing down she felt the rear of her vehicle get struck by the other vehicle.

Neither party sustained any injuries. Vehicle #1 was towed from the scene and vehicle #2 was driven from the scene.

Upon completion of my investigation, vehicle #1 was to be found at fault for crashing into the rear bumper of vehicle #2.

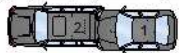
