145. Crash Description/Narrative

On 11/5/2021 at 1335 hours, I responded to the area of the Walmart to a motor vehicle crash with negative injuries.

The driver of vehicle 1 stated she was backing out of her parking spot next to vehicle 2. The driver of vehicle 1 stated she put the vehicle in drive and hit the gas instead of the brake and stuck vehicle 2 which was parked in the spot next to her.

The owner of vehicle 2 stated he was sitting in his vehicle parked when he felt vehicle 1 strike his vehicle.

Vehicle 1 had damage to the front bumper.

Vehicle 2 had damage to the rear bumper and one of the rear parking sensors.

Due to the statements made by both parties, I determined the driver of vehicle 1 to be at fault for the crash. My department issued body worn camera was activated during this incident.

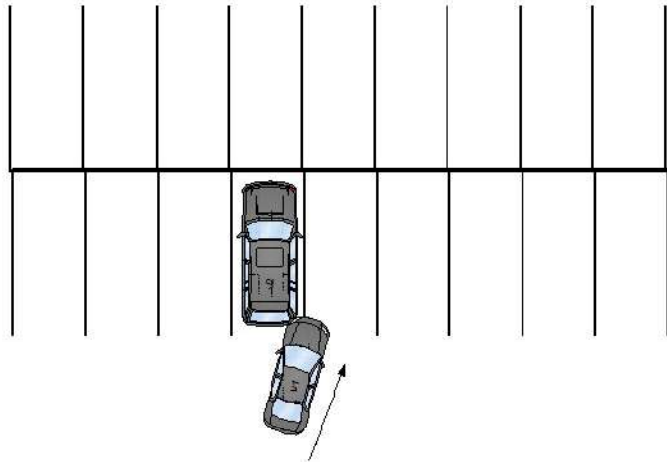
