145. Crash Description/Narrative

A motor vehicle crash occurred on Route 70 approximately 100 feet west of the intersection of Princeton Ave.

Driver #1 stated he was slowing down heading towards the traffic light on Route 70 eastbound when it changed back to green. Other cars around him started to move so he proceeded to ease off the brake. He did not notice Vehicle #2 stopped in front of him and stuck the rear of vehicle #2.

Driver #2 stated she was stopped because of a red light on Route 70 eastbound. She was then struck from behind by Vehicle #1.

There was moderate damage to the front of Vehicle #1 and the rear of Vehicle #2.

Driver #2 had a complaint of pain to her head. Brick Township EMS responded to the scene where she refused further medical attention.

Vehicle #1 struck the rear of Vehicle #2. Driver #1 is at fault for following too closely and driver inattention.

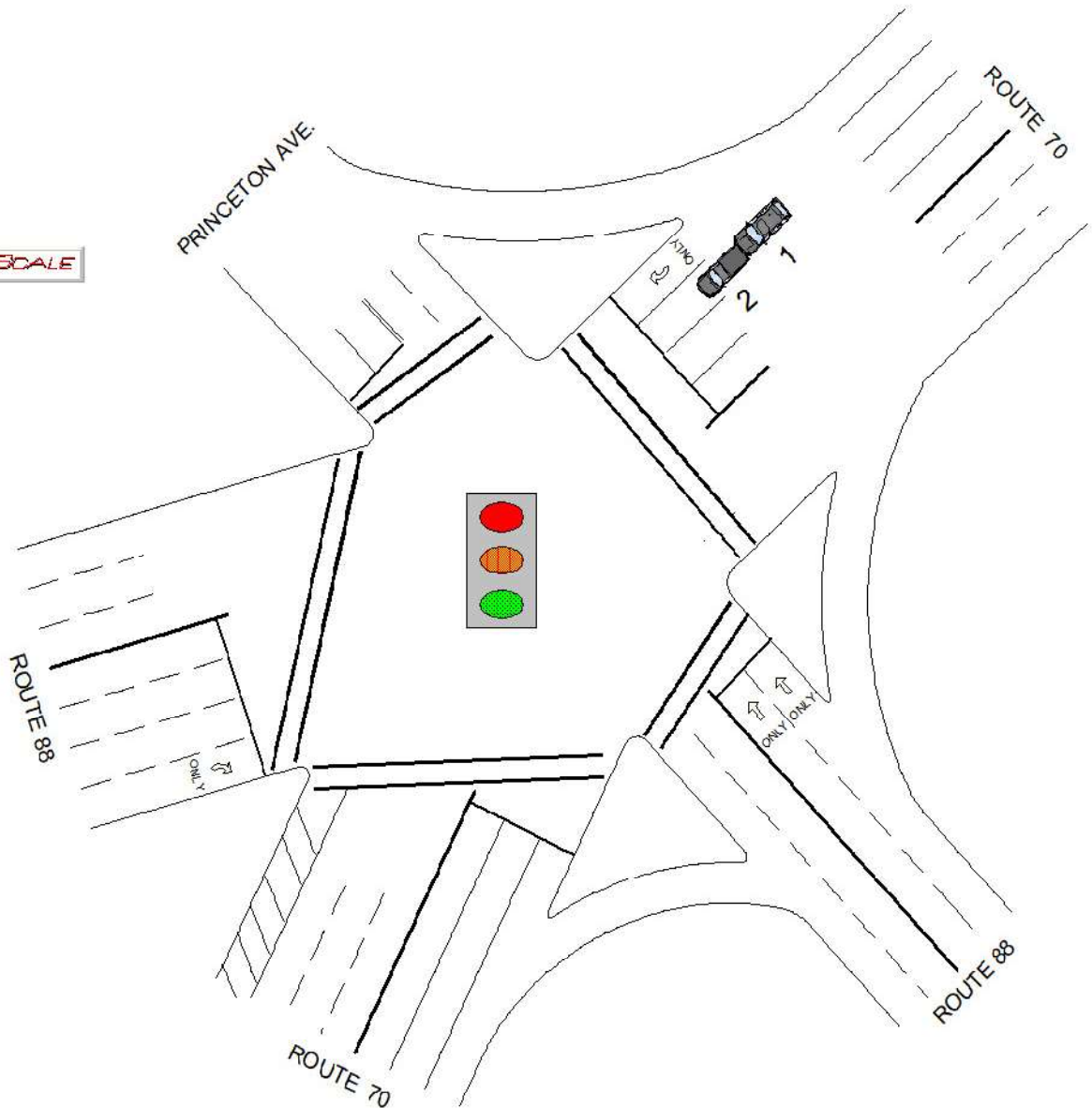
