145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was in the center lane on Route 70 Westbound just prior to the intersection with Jack Martin Blvd.

Vehicle 2 was in the same lane directly behind vehicle 1. Both vehicles were stopped in traffic due to the light being red. Driver 1 put his vehicle into reverse and struck the front of vehicle 2. When the light turned green driver 1 fled the scene and was unable to be located. Driver 2 was uninjured and vehicle 2 suffered damage to the grill, front bumper, and hood.

Driver 2 stated she was stopped in traffic in the center lane on Route 70. She stated vehicle 1 had stopped in close proximity to the vehicle in front of her. Driver 1 placed the vehicle into reverse and subsequently backed into her vehicle.

Based upon the above circumstances I find driver 1 to be at fault for the crash.

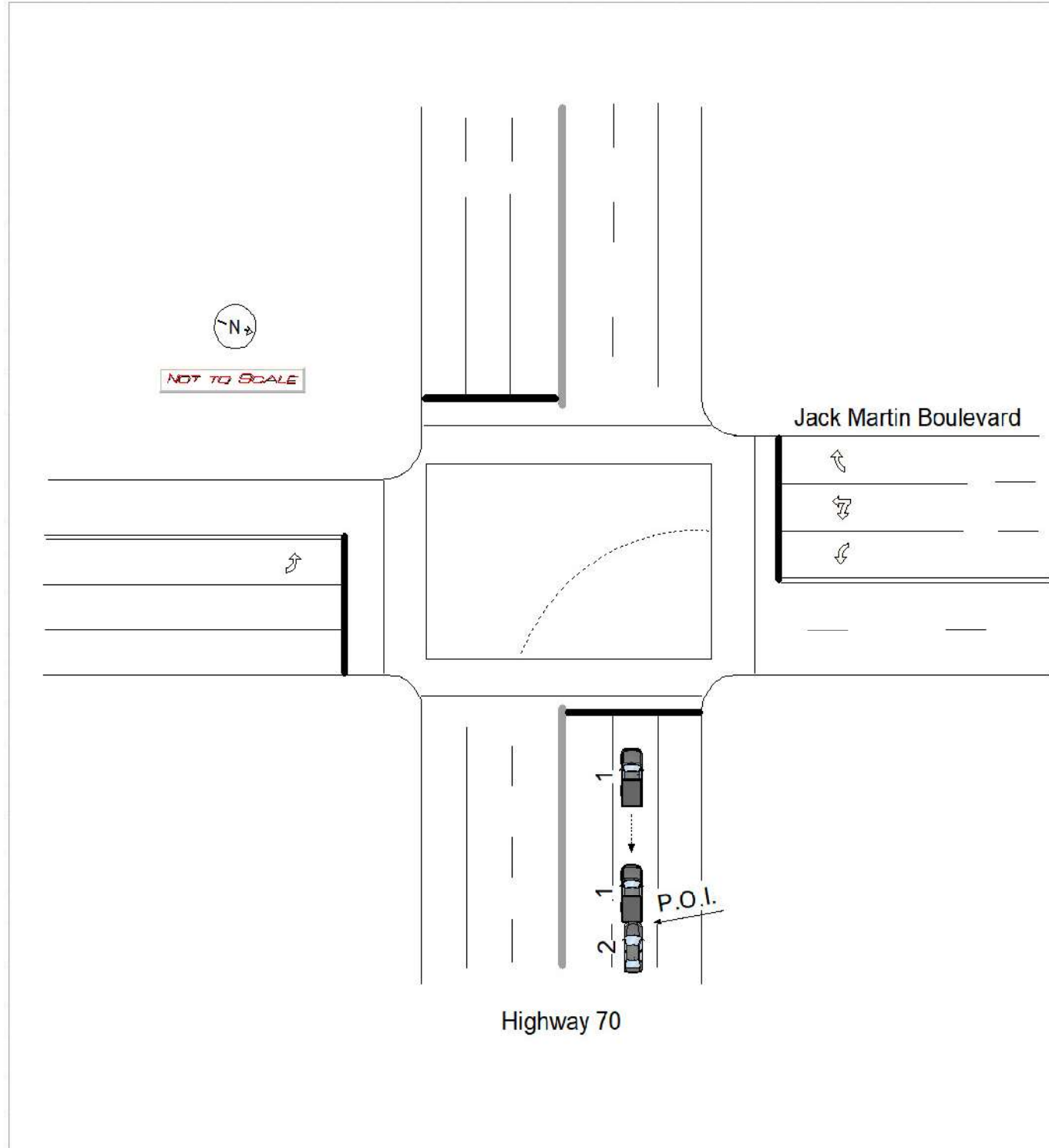
