145. Crash Description/Narrative

Vehicle 1 was in the parking lot of the Home Depot, 1722 Rt. 88, traveling south towards the exit. Vehicle 1 stopped at the stop sign at the exit of Home Depot parking lot and Olden Street. Vehicle 1 was attempting to make a left turn, from the parking lot onto Olden Street, to proceed East on Olden Street. Vehicle 1 started to pull out onto Olden Street, which had traffic in the right lane of travel, from the traffic signal of Rt. 88. The left lane was clear at the time. As vehicle 1 cleared the right lane of travel, vehicle 1's front portion of the vehicle protruding into the left lane which vehicle 2 was traveling west in. Vehicle 1 struck vehicle 2 with vehicle 1's lower right front portion causing moderate/ functional damage to the entire passenger side of vehicle 2. Vehicle 1 also sustained moderate/functional damage from the crash.

Driver 1 stated she was attempting to make a left from the parking lot onto Olden Street. Driver 1 advised there was traffic in the right lane of travel and as she was pulling out she did not observe vehicle 2 travelling in the left lane of travel. As she pulled out past the right lane of travel she struck vehicle 2.

Driver 2 stated he was traveling west on Olden Street approaching the intersection of Rt. 88. As he was near the entry/exit for the Home Depot parking lot, vehicle 1 pull out and struck his passenger side.

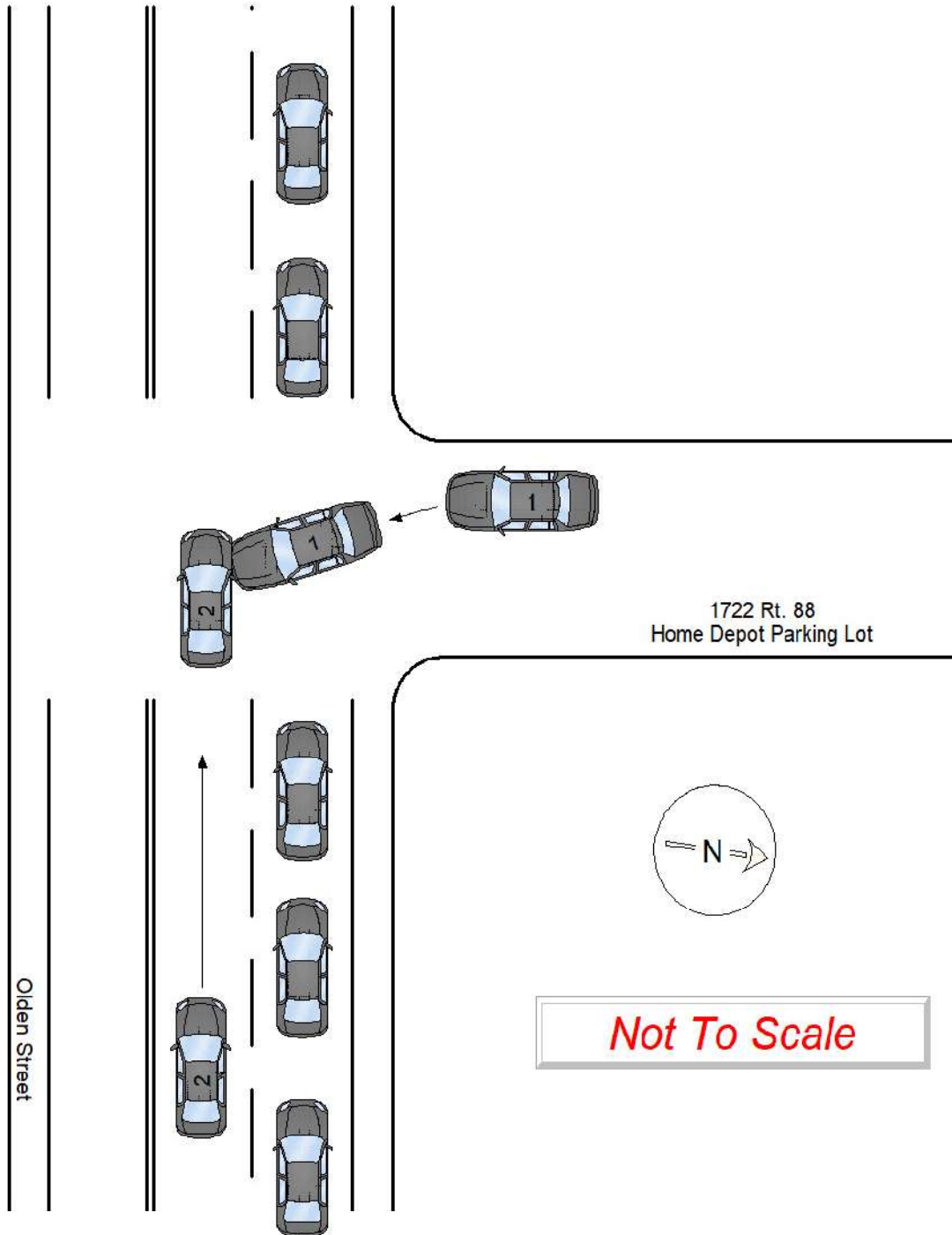
