145. Crash Description/Narrative

Vehicle #1 was stopped at a stop sign on Laurel Brook Drive. Vehicle #2 was traveling East on Route 88 in traffic. Vehicle #1 attempted to enter the lane of travel an struck vehicle #2.

The driver of vehicle #1 stated she thought vehicle #2 was allowing her to enter onto Route 88. Vehicle #2 had space between her vehicle and the vehicle directly in front of her. When she began to enter the traffic lane vehicle #2 moved forward causing her vehicles front bumper to strike vehicle #2.

The driver of vehicle #2 stated she was slowly moving in traffic on Route 88, when her vehicle was struck on the passenger side of the vehicle, by the other vehicle.

Brick EMS responded to the scene to evaluate both parties involved, for precautionary measures. Neither party involved required any additional medical treatment. Both vehicles were driven from the scene.

Upon completion of my investigation, vehicle #1 was to be found at fault for the causing the accident.

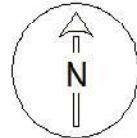
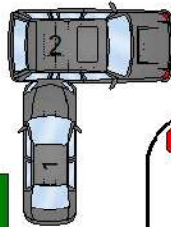
144 Crash Diagram (NOT TO SCALE)
