145. Crash Description/Narrative

Vehicles #1 and #2 were traveling west on Route 88. Vehicle #2 stopped in traffic at the red traffic signal.

Vehicle #1 continued west on Route 88, thus crashing into the rear bumper of vehicle #2.

The driver of vehicle #1 stated she was driving west on Route 88. While driving, she noticed the red traffic signal and began stopping. The driver advised the "sun glare", was in her eyes and was unable to determine the distance between her vehicle and vehicle #2. This caused her vehicle to crash into the rear bumper of vehicle #2.

The driver of vehicle #2 stated she was stopped at the red traffic signal, when her vehicle was struck in the rear bumper.

It should be noted, while on scene speaking with the drivers involved, I didn't witness any type of sun glare and was unable to determine if this was in fact the reason causing the accident.

Neither party involved required medical attention.

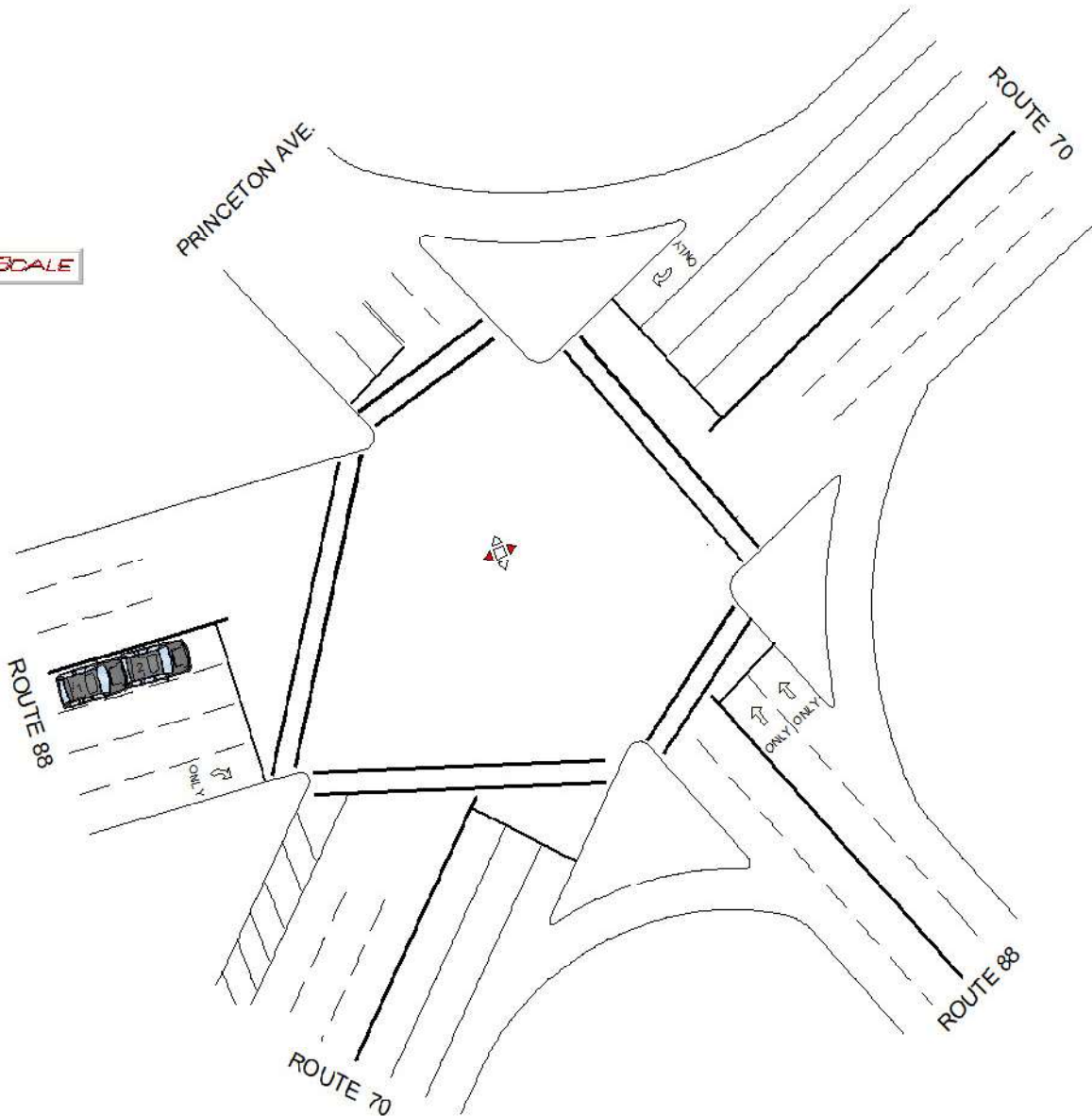
