145. Crash Description/Narrative

Vehicle #1 was traveling east bound on Rt. 88 approaching the intersection of Jack Martin Blvd. in the area of 1530 Rt. 88. Vehicle #1 was stopped in traffic as the driver (Edgar Munoz-Perez) was attempting to make a left turn onto Jack Martin Blvd. Vehicle #2 was traveling west bound on Rt. 88, approaching the intersection of Jack Martin Blvd. The traffic signal on Rt. 88 was green in both directions and the driver of Vehicle #2 (Patrick Rossi) had the right of way as he was traveling straight through the intersection. As Vehicle #2 traveled toward the intersection, Vehicle #1 made a left turn directly in its path. The driver of Vehicle #2 attempted to avoid the collision by laying the motorcycle on its side, thinking it would come to a quicker stop. The motorcycle skidded on its side into the intersection where it was struck by Vehicle #1. Vehicle #1 had damage to its passenger side in the center of the vehicle. Vehicle #2 had damage to its front end and right side.

Edgar Munoz-Perez complained of shoulder/neck pain and was treated at the scene. He refused further medical assistance. Patrick Rossi had several observable injuries to his head, legs, hands, and midsection. It was believed that he also had internal injuries, possible broken ribs and a punctured lung. He was transported to Jersey Shore Medical Center.

Due to the severity of the crash, the Ocean County Prosecutor's Office was notified and Detective Anthony Carrington III responded to the scene. The Ocean County Sheriff's Department was notified to process the scene

and secure the evidence. Both vehicles were transported by OCPO for further investigation.

Edgar Munoz-Perez stated that he was attempting to make a left turn onto Jack Martin Blvd. from Rt. 88. He further stated that he made the left turn without seeing the motorcycle (Vehicle #2) that was heading straight through the intersection. He stated that he turned left in front of the motorcycle and stopped his vehicle after the collision.

It should be noted, the driver of Vehicle #1 is a fault for the motor vehicle accident. Edgar Munoz-Perez was issued summons for Failure to Yield Right of Way and Unlicensed Driver. The driver of Vehicle #2 (Patrick Rossi) was issued a summons for Unregistered Vehicle.

An additional report (Serious Bodily Injury MVA report) will be completed at a later date.

Box #84 (Position in Vehicle Box): This box was filled using 99/other as the occupant (Carlos Coroy) was not sitting in a marked area on the accident report. The rear seat of this vehicle is a bench seat and the four rear occupants sat across the bench.

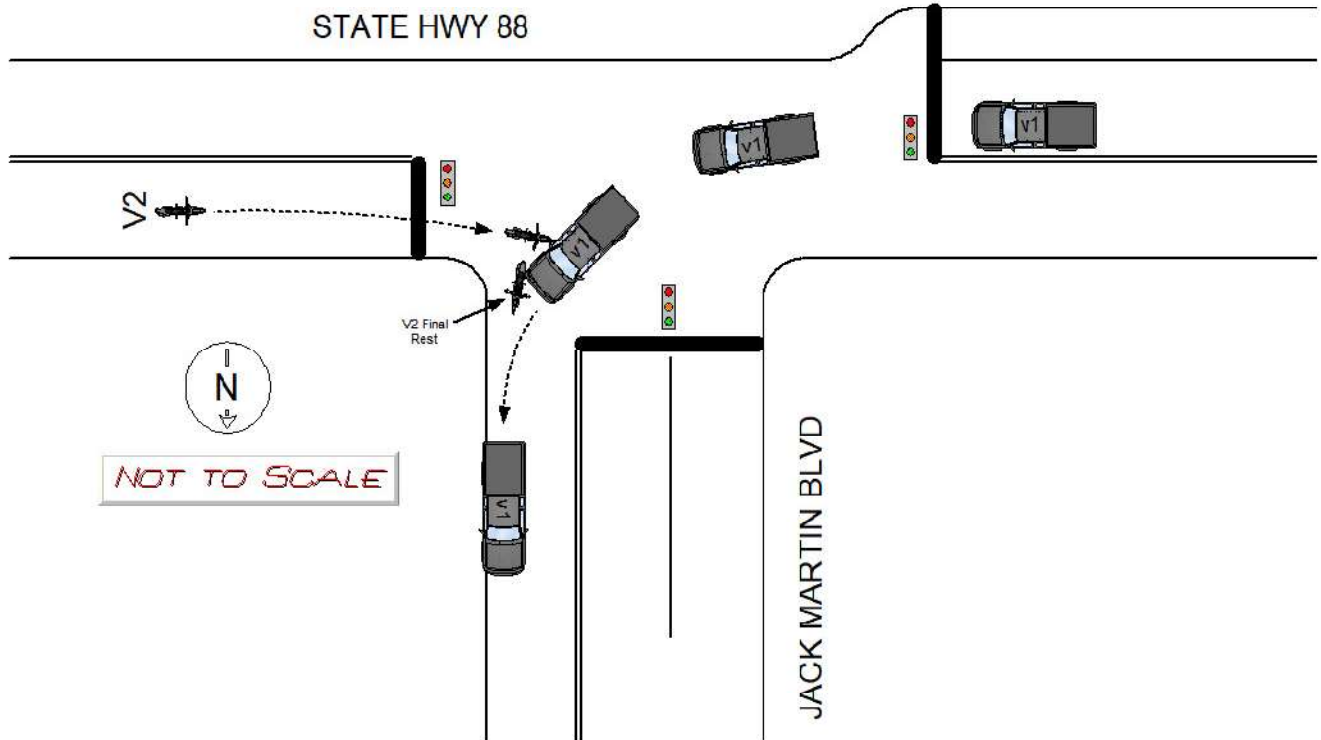
