145. Crash Description/Narrative

Vehicle 2 was stopped in traffic on Rt. 88 traveling west. Vehicle 1 was traveling behind vehicle 2. The crash occurred when vehicle 1 struck vehicle 2 as vehicle 2 was stopped in traffic.

The driver of vehicle 1 stated her foot slipped off the brake causing the crash.

The driver of vehicle 2 stated she was stopped in traffic when her vehicle was struck.

No injuries were reported on scene. I observed damage to the front of vehicle 1 and no visible damage to the rear of vehicle 2.

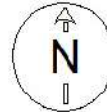
144 Crash Diagram (NOT TO SCALE)
