145. Crash Description/Narrative

Investigation at the scene revealed:

The driver of V2 (Vehicle 2) was stopped at the Route 70 east bound ramp stop sign and was waiting to turn right (north) onto Van Zile Road. The driver of V1 (Vehicle 1) was traveling directly behind V2. The collision occurred when the driver of V1 impacted the rear end of V2. At the scene I observed no visible damage to the front end of V1 and minor damage to the rear end of V2.

The driver of V2 related that she was stopped at the stop sign and was waiting for traffic to clear in order to turn right (north) onto Van Zile Road. While waiting she was rear ended by the driver of V1. The driver of V1 related she believed the driver of V2 was beginning to accelerate when she impacted / rear ended V2. The driver of V2 also stated she could not see in front of her due to the sun interfering with her vision.

The driver of V1 stated she was uninjured and declined first aid. The driver of V2 related she had sustained minor pain to the back of her neck but declined first aid treatment. The driver of V1 provided me with a Montreal Quebec drivers license (#K500815049812). When asked about her current residence status, she related she had moved

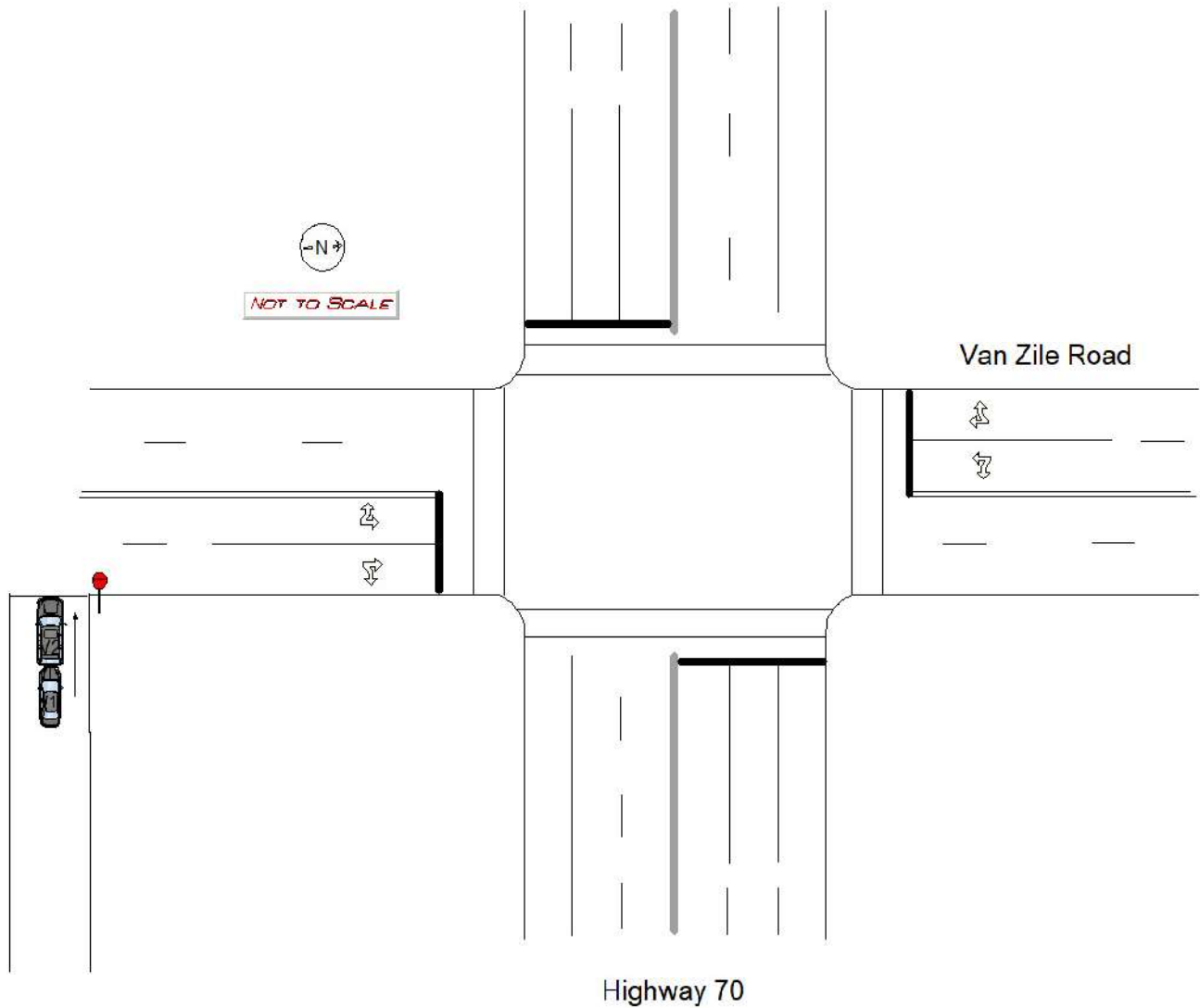
