145. Crash Description/Narrative

On scene investigation revealed the vehicle 1 was traveling south on Burrsville Rd while vehicle 2 was traveling north on Burrsville Rd. Vehicle 1 attempted to execute a left hand turn onto Jack Martin Blvd at which time vehicle 1 struck vehicle 2. The drivers provided the following statements:

Driver 1 stated that she was traveling south on Burrsville Rd. She attempted to make a left hand turn onto Jack Martin Blvd. She struck vehicle 2 who was traveling north on Burrsville Rd. Driver 1 stated she did not see vehicle 2 approaching. Driver 1 did not report any injuries on scene. She was evaluated by BTPD EMS and was released with an RMA. Vehicle 1 had heavy front end damage resulting in the vehicle becoming disabled. Vehicle 1 was towed by D&L Towing.

Driver 2 stated he was traveling north on Burrsville Rd when he observed vehicle 1 waiting to execute the left turn. As he continued through the intersection he stated that vehicle 1 collided with his vehicle. He stated driver 1 exited her vehicle and told him she did not see him coming. Driver 2 was transported by BTPD EMS to Ocean Medical Center due to complaints of pain to his chest. Vehicle 2 had heavy front end damage as well as multiple air bag deployment resulting in the vehicle becoming disabled. Vehicle 2 was also towed by D&L Towing

for Surfside Towing. The front seat passenger had a minor laceration to the head and was treated by BTPD EMS on scene and released with an RMA. The rear seat passenger had complaints of pain to his neck and back. He was also transported to Ocean Medical Center by BTPD EMS.

Based on the statements made by both drivers and damage to the vehicles consistent with the statements provided, I find the driver of vehicle 1 to be at fault for the collision. Driver 1 was issued a summons for Careless Driving (39:4-97) and given a pending court date. Victims with injuries were provided a information copy of the court date. No witnesses were present at the time of the crash. See diagram for further details.

BWC was activated during the investigation.

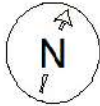

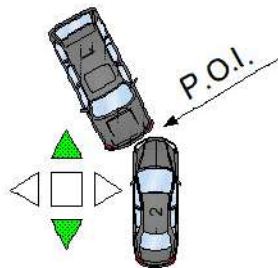
