145. Crash Description/Narrative

On 10/29/2021 at approximately 1923 hrs. I was dispatched to the area of RT 70 EB near the intersection of Jack Martin Blvd for a report of a Hit AND Run motor vehicle accident. The caller, Driver 2, stated there was no area for him to pull over so I met the driver at his residence at 420 Godfrey Lake Drive. Investigation revealed: V1 was traveling east on RT 70 in the far right lane as V2 was traveling in the center lane. Approximately 150-200 feet east of Olden Street, the far right lane was beginning to merge into the center lane. As V1 attempted to merge into the center lane, it struck V2 on the front passenger door, fender, and bumper which I confirmed the damages. As V1 attempted to merge again into the center lane, it struck V2 a second time in the same location.

I spoke with Driver 2, Shawn Safatle, who stated while traveling east on RT 70 at the aforementioned location, he observed V1 attempting to merge into his lane. V1 struck V2 on the passenger side of the vehicle. Shawn stated after the initial impact, V1 attempted to merge again striking his vehicle. Shawn stated he attempted to signal Driver 1 by honking his horn and activating high beams but V1 continued to drive away.

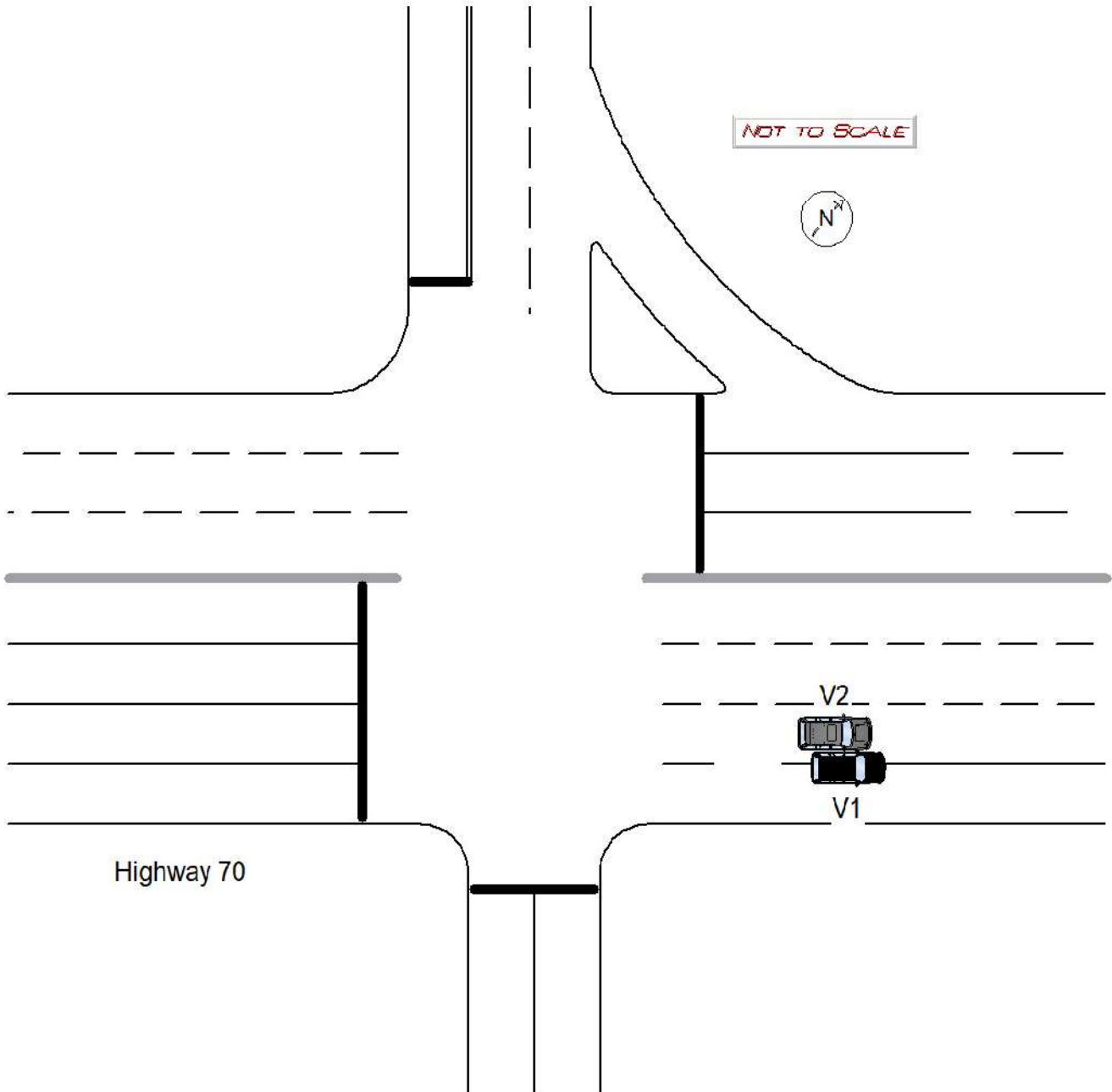
