145. Crash Description/Narrative

Investigation reveals vehicle 1 & vehicle 2 were traveling west on Rt. 88 approaching Folsom Rd.

Driver of vehicle 1 states as she was driving, she looked down for a moment to look at her cell phone and she struck vehicle 2.

Driver of vehicle 2 states she had stopped for traffic in front of her when vehicle 1 rear ended her.

The front airbags were deployed in vehicle 1. Brick EMS responded and driver of vehicle stated she suffered no injuries. Driver of vehicle 2 also stated she had no injuries.

Driver of vehicle 1 was issued a summons for Use Of A Handheld Device (39-4-97.3) E17 007908.

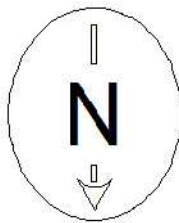
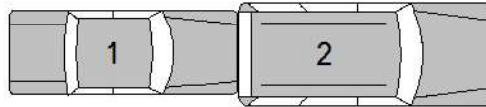
