145. Crash Description/Narrative

On scene investigation revealed, vehicle #1 and vehicle #2 were still in the roadway on Route 88 and Jefferson

Drive. Vehicle #1 was facing north with the body of the truck across Route 88. Vehicle #2 crashed head on into the center of vehicle #1.

Driver #2 stated he was traveling westbound on Route 88 when vehicle #1 came out of the Shore Restaurant Supply parking lot. Driver #2 could not stop in time, causing him to crash into vehicle #1.

Driver #1 stated he has been having problems with his vehicle. While pulling out of the parking lot of the Shore Restaurant Supply parking lot, he could not stop his vehicle because his transmission broke causing vehicle #2 to crash into him. When asking Driver #1 for his information he could not provide me with an insurance card or a drivers license. He was told to fax or bring a current insurance card to Brick Headquarters. He provided those documents on 12/13/2017 at HQ.

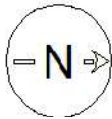

Motor Vehicle Crash Diagram

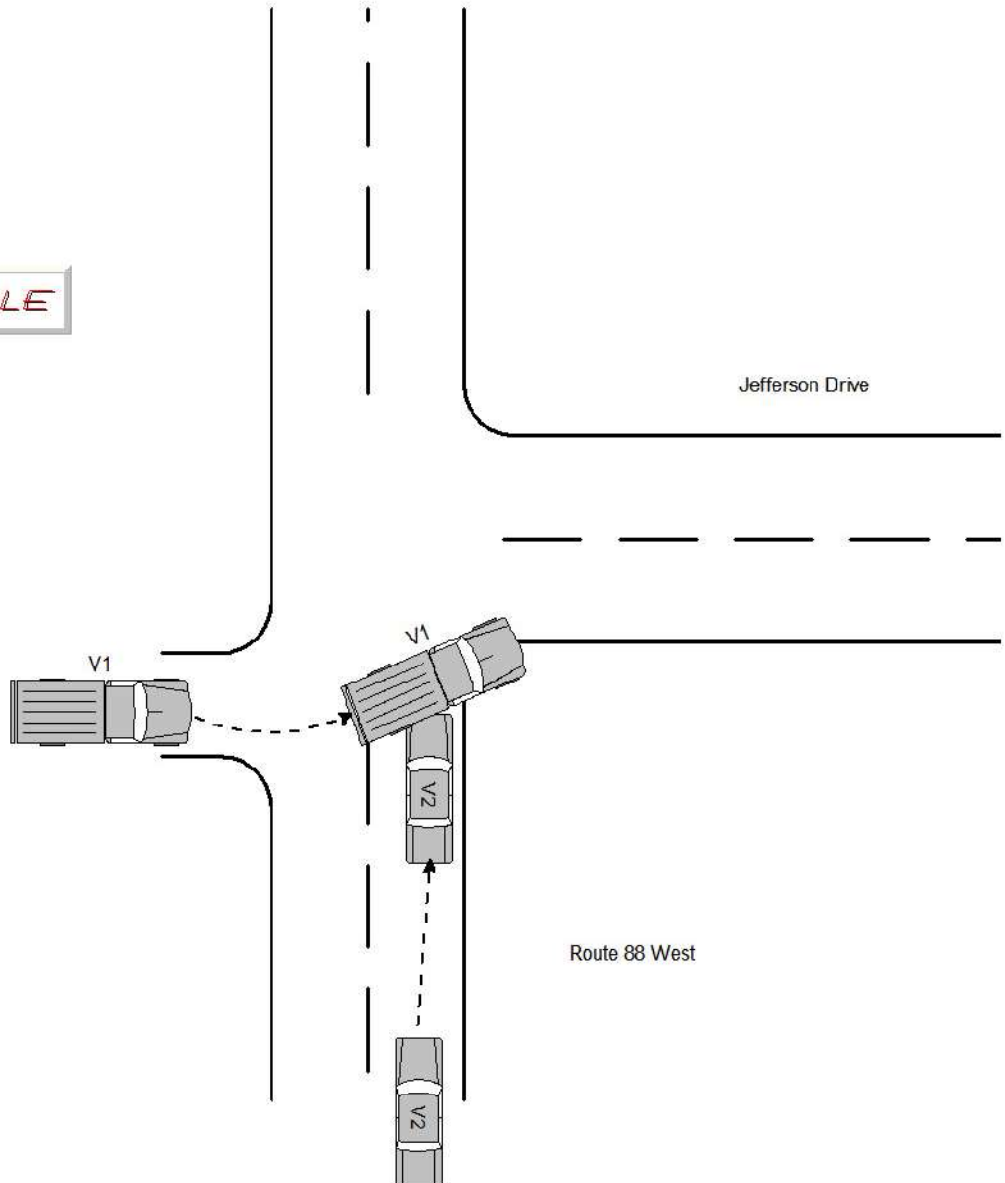
